

The War of Worship Between Two Opposing Bloodlines

Evil is upon the Earth, partly because God's bloodline through Adam and Eve was purposely corrupted by the evil one, Satan. It was done early on in Eden and began with Satan's lie as the cunning serpent. His plan brought about corruption and death into God's creation *and* an opposing bloodline to Adam's posterity. It began with a lie to Eve, after which Satan then convinced her to *disobey* God by partaking of the "**forbidden fruit**". This fruit was the grape, and rather than the natural, *sweet* fruit of the vine, the evil one employed fermented grape juice and the *bitterness* of alcohol to *beguile* Eve. The **sin** in partaking of this fruit then led to the *bitterness* of physical **death** and **hell** for Eve, Adam, and their posterity, along with their *separation* from God.

Partaking of the forbidden fruit also led to the two opposing bloodlines on Earth, and from two different fathers. The result has been continual **enmity** between them. We read in two different translations of Genesis 3:15 about these two opposing bloodlines.

"And I will put **enmity between thee** [the serpent] **and the woman**, and **between thy seed** [through the serpent] **and her seed**; it [He, Jesus Christ] shall bruise thy head, and thou [Satan] shalt bruise his heel"
(King James Version of Genesis 3:15, 1611 AD).

"And I will put **enmity between thee** [Satan] **and the woman**, and **between the seed of thy son** [Cain], **and the seed of her** [and Adam's] **sons**; and it shall be **when the sons of the woman keep the commandments** of the law, they will be prepared to **smite thee** [Satan] **upon thy head**; but **when they forsake the commandments** of the law, thou will be ready to **wound them in their heel**. Nevertheless for them there shall be a **medicine** [via repentance & the blood of Christ - the Lamb of God], but **for thee there will be no medicine** [no forgiveness for you as a son of perdition]; and they shall make a **remedy for the heel** in the days of the King Meshiha [Jesus Christ]"
(Palestinian "Targum" [translation] of Genesis 3:15, 500 BC).

Both the KJV and Palestinian translations of Genesis 3:15 above are prophecies addressing two opposing seed-lines on the earth; that of the woman Eve ("her seed") and that of Satan ("your seed"). The ultimate fulfillment of "her seed" is believed to be that of the Only Begotten Son Jesus. He came via the genetic mixing of the earthly seed of Mary with the heavenly or divine seed of God the Father. It is reasonable to assume that the fulfillment of "your" or Satan's "seed" in Genesis 3:15 is similar, fulfilled in the latter-day anti-Christ, yet first introduced in the Garden of Eden with Lucifer or Satan, via the mingling of his seed with that of Eve. God apparently allowed this to occur as part of His great plan of agency or choice, tied to the principle of "opposition in all things". Thus, "the mark of the Beast" - at its most a basic level, is that of corruption of human DNA through the serpent's seed, removing man from the image, power, and presence of God, through corruption of the blood (DNA).

The Atonement of Jesus in the meridian of time accomplished many things for the humble and repentant, one of which is restoration of purified blood via the great love of Father, of Mother, and the saving grace of their Only Begotten Son. This restoration begins to occur as we come unto Christ and are born again in Him. In it we begin receiving the sanctifying effects of His Atonement spiritually *and* physically (see part III of this paper).

The introduction of an opposing, corrupted bloodline on earth and the corruption of God's pure creation generally, were part of Satan's plans all along. And part of a great battle that remains with us today, one tied to **who we will worship**; the living God, or the usurper Satan. He wants God's throne and power (Isa. 14:9-15). The story of what really happened in Eden is part of Satan's great desire for power. The original Eden story is the focus of the first portion of this paper, a story removed from most of the scriptures we use today. There has also been further corruption of the blood of Eve and Adam since Eden, and more plans for it today via "trans-humanism" research, or the purposeful manipulation of our DNA. There are ways to reverse the seeds of pollution and death in our blood and return to "the image of God" in the pure DNA given our first parents. This is addressed at the paper's end.

We know that a wise and loving Father and Mother sent their **Only Begotten Son** to earth in the meridian of time - with His *pure* bloodline, to reverse the effects of this corruption. He overcame **sin, death, and hell** brought on in Eden first by Satan's *beguilement* of Eve. The LORD Jesus gave His blood for us, and in perfect obedience to the will of Father and Mother. Their plan of redemption and life eternal requires *belief* in Yeshua, their precious, only Begotten Son. We must *repent* and be *baptized* by water *and* then be baptized by fire and the Holy Spirit (see John 3:3-10). The plans of the evil one to first deceive or beguile Eve and then get her to partake of fermented grape juice - *the forbidden fruit* from the **vine tree** in Eden - was key to his success. She then gave birth to Cain and Abel as twins, the seed of two different fathers. Eve then discovered who it was that had beguiled her. Her eyes were opened.

Various scriptures point out these unfamiliar truths. Most of them have been edited out of our modified 1611 King James Bible. The truth yet remains in a much earlier translation of the first five books of Moses (the Torah), known as the Aramaic and Palestinian targums¹ ("targum" is Hebrew for "translation"). They were created around 500 BC or 200 some years prior to the Greek Septuagint - the earliest known translation of the five books of Moses. The older Aramaic translation (and other texts used hereafter) reveals the truth of what happened in Eden, and many others (see these scriptures in **Part II** of this paper, pages 17-23). Another truth is that Jesus - as "**the Word**" - was Jehovah of the Old Testament, and was once part of the five books of Moses (Genesis, Exodus, Leviticus, Numbers, and Deuteronomy). We see Him first as **the Creator**, under direction of Father and Mother.

The Aramaic Targum is the oldest known translation of the 5 original Hebrew texts of Moses. Jewish priests returning from the 70 years of Babylonian captivity created the Aramaic and Palestinian "Targums" (Hebrew for "translations"). They were put together for the average Israelite who no longer utilized Hebrew, after 70 year's among those speaking mostly Aramaic. The Jewish priests translated the Hebrew scriptures into Aramaic for them. These texts were later translated into English by J.W. Etheridge - in 1862. Hereafter, these and other sources are used to support this mostly unfamiliar narrative. They include the 1611 King James Version of the Bible, and Apocryphal sources like the Book of Enoch, the Protoevangelium of James, and the Apocryphon of John (from the Dead Sea Scrolls), along with a variety of extra-Biblical or non-canonized texts. One of these is a mostly ignored 1867 version of the KJV Bible, known as the JST, or the Joseph Smith Translation (the LDS Book of Moses is the JST version of Genesis). It too puts Jesus Christ back into the Creation account.²

No matter which written source we use, we each have access to THE truth of *all things* - by turning to God in prayer. As we do so, praying in the Spirit, seeking truth in God's will, we can receive it (see D&C 46:30; 1 John 5:14-15). To receive truth, we must first remove all "the idols in our hearts". These heartfelt idols are pre-conceived biases, things we hold as true which are not. They greatly affect our potential answers in prayer, which can come from (1) the evil one, (2) from our own mind, or (3) from God. The prophet Ezekiel shares this very important concept with us in Ezekiel 14:3-7. It is one of eight scriptures tied to receiving personal "*revelation*" that is *pure* and undefiled, based on seeking **God's will** and **the truth as it really is** - past, present, or future (Jacob 4:13; D&C 93:24). With *pure* revelation, the truth of *all things* may be obtained (good "idol in the heart" scriptures include Ezek. 14:7; Prov. 23:7, Isa. 66:2-4, 2 Thess. 2:10-12, James 4:3, and in the Book of Mormon - Jacob 4:14, Alma 29:4 and Mormon 9:28).

A War Over Worship

The less familiar Eden story begins first in the pre-existence in heaven, when Lucifer (meaning "light bearer"), a high-ranking angel there, fell from his high position to become Satan. His *pride* and *jealously* over Christ's standing among the hosts, seen in **the worship** described in Revelation chapter 5, got the best of him. He vowed to usurp God's throne and power. He has opposed God ever since, resulting in the **war over worship** addressed by John in the Book of Revelation. Who we worship leads us to **life** and *blessing* or to **death** and *cursing*. This choice is clearly addressed by Moses in Deuteronomy chapter 30. Many call it "the doctrine of the two ways". Those blessed in choosing God, receive His *mark* or *seal*, whereas those choosing Satan are cursed and receive the *mark* of the beast.

One of Satan's most effective tools in this modern war of **worship** - is the removal of Jesus from nearly everything. Besides taking Him out of most of the Old Testament, the evil one has been very successful in removing Jesus from our schools (along with prayer), and from early American history taught there. The new religion of "science" has replaced our Redeemer as the center of our faith and belief in our schools. Hollywood movies and other entertainment now rarely feature Him. The Bible Holy Days have also been replaced with holidays. The two remaining ones that still address Him (Christmas and Easter) have been heavily modified. Political correctness so

prevalent today, dictates that Christ the LORD be removed from all public settings. With these things, Satan and those following him are preparing the “anti-Christ” to take His place.

This modern war of **worship** is about to reach a critical mass in our once, liberty-centered land. Author Zen Garcia (editor of the book, *The Aramaic and Palestinian Targums* (see endnote 1), points out that over centuries of time, various bloodlines descending from Cain have systematically gathered the power and wealth of this world. They are the so-called “Illuminati”. They know who they are and who their father is. He was Lucifer, the rebel angel who sought God’s power, honor, and throne (see Isaiah 14). He and a third part of those following him were cast to earth. He became “Satan”. Those following him today are given control of most everything, including governments, corporations, the news and entertainment media, our education system, and even leaders of churches. The leaders atop them all lie and deceive to separate us from the living God and to turn us into easily controlled slaves. We then provide them “gain”. Their ultimate goal is worship of their god.

In trade for their worship of the evil one, the Illuminati are promised “gain”. It includes “the things of the world” and “the lusts of the flesh” (see the 7 types of “gain” in 1 Nephi 22:23 of the Book of Mormon). Their gain is “acquired” at our expense. The name “Cain” in Hebrew means “*acquired*” or “**gain**” (Strong’s #7069). He *acquired* his brother Abel’s flocks via murder and secrecy (see Moses 5, also known as JST Genesis 4). Like His father, Cain also acted poorly because of *pride* and *jealousy*. Satan encouraged him to make a sacrifice unto to God that he knew would be rejected. Abel’s sacrifice was accepted. Division, from pride and jealousy, eventually led to Abel’s murder.

Many among the Illuminati today believe they are of the literal bloodline of Cain through Lucifer. They claim their ancestral mother was Eve, but they **do not believe that** Adam is their ancestral “father”. The account of one such individual is especial insightful.³ He expressed concern over whether he, as a descendant of the Illuminati and a “child of Cain”, was genetically different, with a third strand of DNA. He was also concerned over whether he could be spiritually “saved” by the blood of Jesus. The Illuminati have purposely hidden who their father is. Editing of the King James Bible and other records has aided their plans, keeping them in power. Their final goal is to lead as many as possible into worship of *their* father with more lies and deception.

This great last-days deception – tied to who we will **worship** - is part of the “strong delusion” the Apostle Paul spoke of in 2 Thessalonians 2:10-12. They want Christ the LORD replaced with the anti-Christ - put in place by Satan (see John’s book of Revelation). Their plan is to establish a “new world order” with the “anti-Christ” soon rising to power. Satan is behind it all, a **liar** and **murderer** from the beginning (see John 8:18-59, especially 44).

The secrecy of who their father is has allowed them to also retain their massive “gain”. They typically do so by inheritance and carefully arranged marriages with other elite families. This keeps their bloodline from being diluted (just as Israelites were to do via direction from God). Interbreeding is thus common among the Illuminati, much like the royal families of ancient Egypt. Maintaining this select bloodline has been important in the early kingdoms of Europe. It remains so in England today, the center of the world’s Banking.

Significant wealth among elite families controlling the world is maintained by the world’s central banks, which they put in place. These banks print money at will. Profitable commerce in the nations they uphold, maintain tight control via the media, entertainment groups, pharmaceutical corporations, big oil companies, and defense contractors, especially in the wealthiest nations. This keeps their corrupt system of gain in place. America’s great military power and its spy agencies (like the CIA) are used for this kind of nation building. Puppet dictators put in place of these nations are then loaned money to keep them in debt. This helps the illuminated elite centralize, manipulate, and hoard the great wealth of this world, along with other “gain”. It includes power and sex, seen in worldwide pedophilia and child trafficking.

Corrupted nations, led by America in many ways, are becoming ripe for God’s judgment - the focus of the Seven Seals in John’s book of Revelation. They feature seven partial “Trumpet Judgments” first, followed by final and complete judgments of the “Seven Bowl Judgments” of God’s wrath. These judgments are right around the corner and will remove Babylon from among us. The wise among the virgin Bride of Christ are removing themselves from her now. They have oil in their lamps.

Satan's Vow to Usurp God's Power & Throne

Satan is the power behind the Illuminati and their corruption of the earth. They strive to take away individual liberty in nations around the world. They oppose God at every turn. The Old Testament Prophet Isaiah tells us how Lucifer became Satan, vowing five times in anger to become like “the most High” by usurping God’s throne. Isaiah informs us that many kings of the earth later came to realize that their path of sin for gain with him - made them weak. These kings detailed Lucifer’s 5-part vow to take God’s throne, saying:

“Art thou also become weak as we? art thou become like unto us? Thy pomp is brought down to the grave, and the noise of thy viols: the worm is spread under thee, and the worms cover thee. How art thou fallen from heaven, O Lucifer, son of the morning! how art thou cut down to the ground, which didst weaken the nations! For thou hast said in thine heart, I will ascend into heaven. I will exalt my throne above the stars of God: I will sit also upon the mount of the congregation, in the sides of the north: I will ascend above the heights of the clouds; I will be like the most High. Yet thou shalt be brought down to hell, to the sides of the pit” (Isa. 14:9-15).

Today, those following Satan include many world leaders seeking station, control, comfort, material luxury, and sex, like Satan – the liar and murderer from the beginning. He was not interested in the wellbeing of his brother. Many of these leaders are of the bloodline of Cain (see John chapter 8). He was the first of Satan’s opposing bloodline here on earth. He murdered his twin brother Abel for “**gain**” - his flocks. And like his father Satan, he chose **self-will** and **gratification** over **God’s will** and the welfare of his brother. Satan **lied** to him too, as reflected in Cain’s early sacrifice in the first fruits of the field – a sacrifice he and Satan chose to give God. Abel, on the other hand, sought **God’s will**, providing the sacrifice He chose, that of the blood of an innocent lamb. It symbolized the future sacrifice of God’s Only Begotten Son Jesus Christ, who would come here in love to save believers (see John 3:16).

Invited by God or Enticed by Satan

Many scriptures address agency or **free will** and our choice between two opposing ways here on the earth – that of life or death, blessing or cursing. We can heed God’s invitation to choose Him and His ways – and thus **life**, or to follow the enticing, worldly ways of Satan, resulting in **death**. Moses taught the doctrine of the “**two ways**” in Deuteronomy 30:15-20. It summarizes the essence of the entire law God gave Moses and the Israelites. Moses said:

“I have set before thee this day **life** and *good*, and **death** and *evil*; In that I command thee this day to love the LORD thy God, to walk in his ways, and to keep his commandments and his statutes and his judgments, that thou mayest live and multiply . . . I call heaven and earth to record this day against you, that I have set before you **life** and **death**, *blessing* and *cursing*: therefore choose **life**, that both thou and thy seed may **live**”.

Lehi taught a similar doctrine when he pronounced his patriarchal blessing on his son Jacob in 2 Nephi 2 of the Book of Mormon. It presents a clear overview of God’s plan of redemption, featuring the choice or agency God gave man, along with clear ties to the events in Eden. The “fall” that occurred in Eden created the necessity of our LORD’s **blood** Atonement. Lehi stated that God’s plan of agency included the need for “**opposition in all things**” . . . even **the forbidden fruit** [the “**vine tree**”, leading to *death*] in opposition to **the tree of life**; the one being **sweet** and the other **bitter**”. Man is then “enticed by the one or the other”. Addressed hereafter, the **forbidden fruit** in Eden was the choice to believe a lie and then disobey God by partaking of the “**forbidden fruit**.” Satan corrupted the natural **sweetness** of grape juice or *new wine* and turned it to *strong wine* via the **bitterness** of alcohol in fermentation (see Isaiah 5:20-22). It became a drug used to help beguile Eve.

The righteous bloodline of God, in which His only Begotten Son was born, is symbolized in Adam and his *firstborn* son Abel early on in Genesis. Opposing them is the rebellious bloodline of the serpent along with his *firstborn* son Cain through Eve. The two sons were twins, like Manasseh and Ephraim, and Esau and Jacob. Eve became the “mother of *all* living” or of both bloodlines. Cain is not Adam’s son. He became the first murderer in the Bible, taking out Abel. This is put forth clearly in the Aramaic translation of early Genesis, along with other texts, including apocryphal scriptures sometimes called extra-Biblical texts. In this translation two opposing fathers and their bloodlines are clearly present, as Christ addressed in John 8:44, along with the **enmity** existing between them (Gen. 3:15, Aramaic Targum).

There have been at least three major corruptions of the DNA or God's pure blood through Eve on the earth; the first was in Eden, the second was with the Watchers (Book of Enoch) prior to the Flood, and the third is occurring now with hybridized agriculture, the Covid-19 vaccine, corrupted ingredients in food, etc., (see pages 23-28). It is part of the corruption of all things in God's creation, and the continuing war of worship raging again today.

Satan wants men to worship him, as evident in the temptation of Jesus in the wilderness prior to the start of His mission (JST Matt. 4:1-9). It is recorded in the New Testament. Moses was also tempted in a similar way by Satan prior to leading the children of Israel out of Egypt (Book of Moses 1:12-23). His encounter with Satan has been edited out of the KJV Bible. Joseph Smith was also confronted by Satan prior to his bringing forth more truth in additional scripture (JSH 1:11-20). Satan promised all three men the riches of this world if they would bow down and worship him.

The story of the 2 opposing bloodlines is told hereafter in 3 parts. It begins in **Part I** with *the grape* as the **forbidden fruit** in Eden (pages 4-17). It is the longest section of this paper, focused on the fermented grape as "the forbidden fruit". It is the first of 12 total witnesses revealing how Satan corrupted God's plans on earth - early on in Eden.

Part II follows, featuring all remaining sources that point to this reality, many being apocryphal or extra-Biblical "scripture" sources (pages 17-23). **Part III** concludes this paper, addressing how Satan's corruption of Eve's blood affects human DNA. This section also provides hope in addressing how our blood may be purified (pages 23-27).

Part I: The Grape as the Forbidden Fruit - Witness #1 of 12 (pages 5-18)

The introduction of an opposing bloodline in Eden is closely tied to the **forbidden fruit** - the *fermented fruit of the vine*. This becomes clear as we piece together some 200 scriptures tied to **wine** in the Bible along with other sources, like the *Apocryphon of John* in the Dead Sea Scrolls. It connects the fermented **grape** and its **juice** (strong wine) to the beguilement of Eve. This text states that the "**vine tree**" was "**the tree of knowledge of good and evil**" and that its **fruit** was the "**forbidden fruit**" utilized in strong wine. Alcohol, as a drug in strong wine, helped the serpent introduce **sin** in Eden, leading to separation between Eve and Adam and their separation from God. Alcohol is tied to deception, rape, incest, violence, and murder in scripture. It continues to divide marriages and families today. "**Wine**" in the Bible may refer to either non-alcoholic "new wine" or aged, fermented wine.

As alcohol is produced in wine, the *sweetness* of pure or new wine is turned to *bitterness*. About 80 of the 200 wine scriptures in the Bible have ties to the mind-altering alcoholic content of fermented wine. Consuming it leads to drunkenness and potential **sin**. Opposing it is the pure "**blood of grapes**" in new wine, symbolizing the **pure blood of the Lamb** in scriptures, like Genesis 49:8-12, Jacob's patriarchal blessing on his son Judah. Jacob's blessing there

features a promise of the coming of Christ through Judah's bloodline, with hints of His Kingship throughout. It also points us to the triumphal entry of the LORD into Jerusalem, and to the Garden of Gethsemane, where Jesus willingly shed His blood for us, bleeding from every pore (see Luke 22:44, Mosiah 3:7, D&C 19:18).

Our LORD's *pure blood* is represented by new wine used in the Sacrament ordinance. It is *uncorrupted* by alcohol, just as *unleavened* bread is free of leaven or yeast and its fermentation. The **natural fruit of the vine** was modified and then cunningly administered to Eve by Satan. He and strong wine are directly opposed to Jesus and the undefiled natural **fruit of the vine**, symbolized by Jesus as "**True Vine**" (John 15:1-4). He introduced the healing power of the "sacrament of the LORD's supper" to his most trusted disciples, just before His Atonement. His love for them and us is revealed in His pure shed blood, given freely in Gethsemane, the scourging, and the cross. His pure blood, originating in Father and Mother, negates the effects of the **sin** Eden, that led to spiritual and physical **death** for Eve, Adam, and us, and our collective *separation* from God. This is **hell**. Four key Genesis scriptures in the Aramaic Targum reveal much of this (see pages 17 - 23). We begin here, however, with a focus on the grape.

A. The Nazarite Vow Connection

Sin, death, and hell are completely reversed by Christ's blood Atonement, in connection with our belief in the LORD, our repentance, and our baptism by both water *and* fire. **Sin, death, and hell** are also parts of the Nazarite Vow of Numbers chapter 6. There, men and women who desired to become "holy unto the LORD" (anciently or today) were taught to completely avoid *any* contact with the **grape**, including new or aged **wine**, and **raisins**. Why? In a number of scriptures the **grape** has clear ties to the **sin** in Eden, when Eve partook of "the forbidden fruit". Numbers 6 tells us that Nazarites were also to avoid *any* contact with **death**, as in taking care of deceased family members, etc. Nazarites were to become "holy unto the LORD" by **separating** themselves completely from the things of the world that can lead us carefully down to **hell**, those things *separating* us from God. Note the early Aramaic translation of the first few verses of Numbers 6 below. We see Eve's "corruption" by fermented **wine** below in connection with the Nazarite requirement to completely avoid the **grape** (the **sin** in Eden). It led to spiritual and physical **death** for Eve, Adam, and us and **separation** from God, which is **hell**.

"And the LORD spake with Mosheh, saying: Speak with the children of Israel, and say to them: When a man or, a woman, seeing **her** [Eve] who had *gone astray in her corruption*, shall (resolve to) become abstinent from **wine**, or for any other cause shall make the vow of a Nazir in **separating** one's self unto the Name of the Lord, he shall abstain from **wine**, *new and old*, he shall drink neither vinegar of *old wine* or *new*; neither may he drink liquor in which **grapes** have been crushed, nor eat of **grapes** either fresh or dried [raisins]. All the days of his vow he shall not drink eat of **the tree** ["tree of knowledge of good and evil"?] which maketh **wine**, from the husks of **grapes** even to the kernels within them. All the days of his Nazir vow the razor shall not pass upon his head until the time when the days of his **separation** to the Name of the Lord be fulfilled; he shall be *consecrate*, letting the hair of his head grow. All the day of his **separation** to the Name of the Lord he shall not go in where there is a *dead* man. For his father, or his mother, his brother, or his sister [who are dead], he shall not make himself *unclean* through their *decease*; for the **crown** of Eloah [the Hebrew God, singular] is upon his head; all the days in which he is a Nazir shall be sacred [or "holy"] before the Lord."

The differences between the 515 BC Aramaic translation of Numbers 6 and the edited 1611 AD King James Version are significant. The Aramaic translation of this chapter connects Eve's **corruption** in Eden with the **grape** as **the forbidden fruit**. It also addresses the LORD's blessing at the end of the Numbers 6, one that promises to keep Nazarites free from *demonic* influence. Both concepts are removed in the KJV translation.

Red wine is a symbol of the Lamb of God's blood (in *new or fermented* wine). It is consumed by believers today in the Sacrament, along *with* broken bread. It represents His broken body. This bread can be "leavened" by yeast, another form of *fermentation*. Both are symbols of *corruption* in the Bible. This is seen in the Feast of *Unleavened Bread*, a seven-day memorial of the Israelites speedy exodus out of bondage in Egypt. It immediately follows Passover, occurring on the full moon night when innocent lamb's **blood** was smeared on the doors of Israelite homes to protect them from the Destroying Angel. The killing of the firstborn (symbolizing the crucifixion of God's Only Begotten Son Jesus in the distant future in Jerusalem) was the last of Ten Plagues pronounced upon the idols of Egypt *and* Pharaoh (see Exodus chapters 7-14, and the author's paper *Passover: The Real Story*).

It was immediately following the Sacrament ordinance on the night of the Last Supper, and the washing of the feet of the LORD's disciples, that our LORD took eleven of them to the Garden of Gethsemane on the Mount of Olives. There He gave His **blood** willingly for us in the first portion of His blood Atonement. He bled there at every pore (Luke 22:44, Mosiah 3:7, D&C 19:18) when His blood was *sprinkled* on the ground under the full moon of Passover. The next morning, the Lamb of God had more of His precious **blood** *poured out* in the scourging, where His flesh was torn open by Roman soldiers in their "chastisement" of Christ, fulfilling Isaiah 53:5. Finally, His **blood** was *smear*ed on the cross. He suffered there for six hours before He died. These are the 3 ways in which the High Priest utilized animal **blood** - in the holiest places of the ancient Tabernacle and Temple on the Day of Atonement - to symbolize the coming Atonement of Christ. John tells us that "**all things**" are made "**new**" in His **blood** (Rev. 21:5), including *reversal* of the effects of sin, death, and hell. Our LORD's sacrifice thus brings us back into God's presence as we do our part. This potential return is symbolized in the torn temple veil, occurring at Christ's death.

Note how Satan corrupted Cain's offering to God in Genesis, an act that was to symbolize Christ's future sacrifice as the Lamb of God. He knew that Cain's offering of "**fruit**" of the **vine** and other plants would be rejected, leading to even more trouble. This is clear in the JST version of Genesis, chapter 5.

"**And Cain loved Satan more than God.** And Satan commanded him, saying: Make an offering unto the Lord [which I Satan will choose for you]. And in process of time it came to pass that **Cain brought of the fruit of the ground** [perhaps **grapes**, the forbidden fruit, along with others] an offering unto the Lord [this was Satan's choice through Cain, *opposing* God's will]. And Abel . . . brought of **the firstlings of his flock**, and of the fat thereof [Abel followed **God's will**, *not* his own, see JST 5:5-7 RLDS, or Moses 5:18-21 LDS]. And the Lord had respect unto Abel, and to his offering [as it reflected God's will]; But unto Cain, and to his offering, he had not respect" (for more of this event, with related text, see pages 17 & JST Gen. 45-7, Book of Moses 5:18-21).

In the JST version of Genesis we find that the sacrifice of an innocent lamb by Abel, was an important principle first taught to Adam and Eve by an angel. It represented the future sacrifice of the Messiah Jesus Christ.

And after many days an angel of the Lord appeared unto Adam, saying: Why dost thou offer sacrifices unto the Lord? And Adam said unto him: I know not, save the Lord commanded me. And then the angel spake, saying: This thing is a **similitude of the sacrifice of the Only Begotten of the Father**, which is full of grace and truth. Wherefore, thou shalt do all that thou doest in the name of the Son, and thou shalt repent and call upon God in the name of the Son forevermore" (JST Genesis 4:6-8 / Moses 5:6-8).

B. The Kingly Bloodline of Jesus versus that of the Usurper Satan

Kingly bloodlines throughout the world, including those of Ancient Egypt and Israel, and early European nations, stress the importance of not mixing their bloodline with surrounding people. This maintains the "purity" of their specific bloodline. In scripture, the purity of Israel's **royal blood** through Abraham and David was tied to being a physically and spiritually *separate*, a peculiar people chosen unto the LORD. Bible *genealogies* establish the pure, "**royal**" (or legitimate) right to *rule* (as priest) and *reign* (as king) in the House of Israel. It is determined by **blood and** by **righteousness**. Matthew's genealogy at the start of the New Testament does **not** include Eve's son Cain, the firstborn of Eve *and* Lucifer, and yet it does include Seth as the second born son of Eve *and* Adam. Cain **is** found, however, as part of Eve's *genealogy* in the Aramaic Targum of Genesis 5 (see the comparison chart below).

The LORD's *bloodline genealogy* through **Adam** is given us in the book of Matthew, the first book of the New Testament. It is a *bridge* book between the Old Testament prophecies of the coming of Jesus Christ as Messiah, and the New Testament record of His mission among the covenant people. This "bridge" book points to Jesus being this Messiah *and* the legitimate King over all Israel via His **bloodline** through both His step-father **Joseph**, *and* through His unique status as **the Only Begotten Son of God the Father!** Both are tied to **blood**.

Note that Seth (meaning "substitute" for murdered Abel) is said to **look like Adam** in the Aramaic version of Genesis 5, where Cain does **not**. Also note that Cain is **not** included in the genealogy of Adam. We know that the KJV Matthew account was written **to the Jews** (and to Gentiles and others) that they might see how Jesus was the fulfillment of Old Testament prophecies pointing to Him as *the* promised Messiah and Israel's rightful King (see Gen. 49:8-12 & Isaiah 53). It features His paternal bloodline genealogy to confirm His **Kingly** status (*firstborn* sons

became the next king). Seven Bible scriptures also address Christ as “*the* Prophet” (see Deut. 18:15; John 5:46-47, 7:40; 1 Ne. 22:20-21; 3 Ne. 20:23, 28:34). Because the Jews drifted away from God, they didn’t recognize His Son Jesus as this special “Prophet” and King among them. He nevertheless was *and* is “the way, the **truth**, and the life” (John 14:6) - the Great High Priest (Heb. 4:14-16) *and* the King of kings (Deut. 10:17; Gen. 49:11; Rev. 19:16) who will soon return.

And last, note also below - that the word “**similitude**” in connection with Seth – is separate from “**image**” or Seth’s physical likeness to his father Adam. The word similitude is used again by Moses in JST Genesis 4:6-8 / Moses 5:6-8 in describing why Adam made sacrifice to God using a lamb, as it pointed to the future Messiah Jesus. Some suggest Jesus was Abel, the firstborn son of Adam and Eve in another mortal probation.⁴ Jesus said that He was **with the Father from the very beginning**” (John 1:1, 10:30 & 17:5).

“This is the book of the **genealogy of Man**. In the day that the Lord created man, in **the likeness** of the Lord He made him. Male and female He created them, and blessed them in the name of **His Word** [Jesus]; and He called their name Man in the day they were created. And Adam lived a hundred and thirty years, and begat Sheth [Seth], **who had the likeness of his** [Adam’s] **image** and of **his similitude**: for **before** had Kava [Eve] born Kain [Eve and Satan’s firstborn son], **who was not like to him** [Adam]; and Habel [Abel] was killed by his [Cain’s] hand. And Kain was cast out; **neither is his** [Cain’s] **seed genealogized in the book of the genealogy of Adam. But afterwards there was born one like him** [Adam], and called his name **Sheth** [Seth]” (Aramaic Targum of Genesis 5:1-3).

“This is the book of the generations of Adam. In the day that God created man, in the likeness of God made he him. Male and female created he them; and blessed them, and called their name Adam, in the day when they were created. And Adam lived an hundred and thirty years, and begat **a son in his own likeness, and after his image**; and called his name **Seth**” (KJV Genesis 5:1-3).

Cain is the *firstborn* son of the evil one through Eve (Genesis chapter 4 features the Old Testament generations of the serpent’s bloodline, the tares), just as Abel was the *firstborn* son of Adam *with* Eve (Gen. chap. 5 features the Old Testament generations of Adam’s bloodline, the wheat). The boys were twins. Eve became the “mother of all living” with them. The true father of Cain has been edited out of the King James Version of the Bible. This occurred as it went through many Jewish leaders, scribes, and editors to get to us, *and* through Catholic Church editors.

C. The Diadem, Symbol of Legitimate Right to Rule via Blood

As addressed briefly earlier, the “**diadem**” is a special turban-style crown found in just 5 verses in the Bible. It symbolizes the “**royal**” right via **blood and righteousness** to lead as King over the Kingdom of God. It is made of cloth and is often studded with jewels. In the book of Revelation, the rare word “**diadem**” signals the **royal, legitimate** authority of **Jesus Christ** to rule and reign as the King of kings, and the LORD of lords, based on both His **royal bloodline** (as the Only Begotten of God the Father) *and* His clear **righteousness** (one of our LORD’s titles is “Son of Righteousness”). John tells us a very important truth when He states that Jesus’ return in the second coming will be marked by His wearing of multiple **diadems** (see Revelation 19:12).

In Nelson’s Student Bible Dictionary we read, “rulers of the Ancient Near East did not wear *rigid gold crowns* but *cloth turbans* wound around the head and decorated in turn with cloth **diadems** studded with gems” (see Ezek. 21:26-27 & Mal. 3:17). In the New Testament, *garlands* or *wreaths* are another type of *crown*. Some *wreaths* were worn to symbolize faithful service, like Roman leaders.

The word “**diadem**” appears in only four KJV Bible verses; 1. Job 29:14; 2. Isaiah 28:5; 3. Isaiah 62:3, and 4. Ezekiel 21:26-27. A fifth use of “**diadem**” is found in the bloodline of Joseph in the Aramaic “translation” of Genesis 49:26, where “crown” is translated more correctly as “**diadem**”. It is Jacob’s patriarchal blessing upon the head of his birthright son Joseph (of Egypt). He too had the “**royal**” right to lead via both his *birthright* status (in the **blood** of Jacob his father) *and* because of his **righteousness**. Both characteristics are necessary for a legitimate leader, one of “**royal**” right. Isaiah also ties the “diadem” to a “crown of glory” and to “righteousness” (Isa. 62:2-3).

1. Job wore the **diadem** for his faithfulness *and* **righteousness** in Job 29:14.
2. In His last-days return, Jesus, also called “**the Righteous**” (Moses 7:45 & 47) wears a **diadem** in Isaiah 28:5.
3. This **righteous** last-days Davidic (or **royal bloodline**) Servant wears a **diadem** in Isaiah 62:3.
4. A wicked usurper has his false diadem removed in Ezekiel 21:26-27. It is reserved for one whose “right” it is to have because of **blood and righteousness**.
5. Joseph of Egypt (a **righteous birthright** son of Jacob) was given a **diadem** in Jacob’s **patriarchal** blessing in Aramaic Targum or translation of Genesis 49:26 (see also JST Genesis 48 & 50).

The word “*crown*” and “**diadem**” in the KJV are not always translated correctly. Although Christ’s **righteousness** is mentioned in Revelation 19:12, His **royal patriarchal bloodline authority** is not. It would have provided Him true *legitimacy* to lead Israel as her rightful King and High Priest via both characteristics. Jesus has many “**diadems**” on his head in Revelation 19:12, rather than the traditional metal “crowns” of corrupted, earthly kingdoms. Usurpers to the throne typically have neither **royal blood** nor **righteousness**.

The Diadem Connection to the Grapevine & Nazarites

The word “**diadem**” is a variant translation of the word *nazir*, meaning “crowned” with **righteousness spiritually**. It is uniquely associated with a *grapevine* and the long, covering hair of Nazarites, while also symbolizing the **royal or legitimate right** to rule via blood in scripture - God’s blood in Yeshua, His Only Begotten Son. Christ is also qualified to be King of kings because He is a model of righteousness, the Son of Righteousness. He is called “**the Righteous**” in Moses 7:45 and 47. He is also called the **True Vine** in John 15:1-5.⁵ The fruits of His love are visible in the Atonement. Significantly, the long hair of the Nazarite symbolizes a covering of **righteousness**, tied symbolically to an uncut, full **grapevine**. In *The Encyclopedia of Biblical Literature* we read:

“Whilst the **vine** again, laden with *fruit*, is called *Nazarite*, or more probably *Nazir*, i.e., the *crowned* (Lev. 25:5;11); because in its *uncut* state, when its **head is covered** with **grapes** and foliage, it is a much adorned with a **diadem** as the head of the *Nazarite* with the abundant *hair*, just as we call the foliage of a tree its *crown*” (see *The Encyclopedia of Biblical Literature*, Kitto & Alexander eds., vol. 3, p. 293).

The serpent lied to Eve then convincing her via deception to consume the “**forbidden fruit**”. Satan used it in modified form as a *drug* to take advantage of her. She was Adam’s choice, beloved companion. Satan targeted this pure vessel in act of hatred and revenge upon Adam and Eve and their blessed bloodline. It was also an attack on the sacred act of creation between a man and a woman. In no way should Eve’s beguilement in this paper be viewed as a negative portrayal of women or of creation. All of us are deceived from time to time. Errors are part of life experience and the choices made when confronted with necessary opposition in all things.

Besides avoiding all things tied to **grapes** in Numbers chapter 6 (including **wine** and **raisins**), Nazarite’s were not to cut their hair. Its length symbolized the length of their special covenant or “vow” with God, whether the Nazarite was a man or a woman. The length of time of the vow had to be a minimum of 30 days or more, all the way up to an entire lifetime, like Sampson. The length of hair covering of the Nazarite reflected this. It was also like a *crown* (of glory), one tied to their *righteousness*. The Nazarite vow helped one become “*holy unto the LORD*” leading to choice blessings, including God’s presence (see the end of Numbers 6). Nazarites were also to have **no** contact with with **death** in their covenant with God. This is because both the **grape** and **death** are tied closely to the **sin** of Eve and Adam in Eden, leading to the introduction of an opposing bloodline on this earth, a bloodline that has fought against God from the beginning! The **sin** in Eden brought about *physical death* for Eve and Adam, and thus their **separation (hell)** from God. Jesus, as the Son of God came to overcome **sin, death, and hell** in His Atonement. He was victorious in it because of **His righteousness** and His **pure blood** through the Father - shed for us.

There are many Nazarites in the Bible. They include a number of barren or aged *women* in the Old Testament who wanted children and made a vow with the LORD to obtain a son. The mothers of Sampson and Samuel the Prophet are two good examples. We also have men like Paul the Apostle, James the Just, and Christ the LORD who was from Nazareth. He is believed to have had long hair and made a vow to not drink wine (Matt. 26:29).

Roman soldiers forced our LORD to wear a *crown* of thorns at His crucifixion. In reality it represented His **righteousness** (2 Tim. 4:8) along with His **royal patriarchal bloodline** through the Father. He was worthy to

perform the Atonement for us and open the seven seals of the Book of Life in Revelation. This worthiness is addressed clearly in Revelation chapter 5. Satan and the anti-Christ representing him, do **not** possess the legitimate (or royal) **bloodline** to lead, nor the **righteousness** necessary to rule over the souls of men on earth.

The Usurper Satan John the Revelator addresses the reality of Satan's attempt to usurp power on earth in the last-days in Revelation chapters 12 and 13. He does so via the anti-Christ there. He wears a worldly *crown*, where our returning LORD at the Second Coming *should* be wearing "many **diadems**". As addressed earlier, a poor KJV translation of Revelation 19:12 has given us "many *crowns*" instead of the **diadems**. According to Phelps, "The author of Revelation uses the image of **diadems** to expose **illegitimate rulers** of the temporal realm and affirm Christ's **royalty** over all of creation, including but not limited to the temporal realm. Christ is Lord of heaven and earth, of all time, of all peoples. Any ruler who wears the **diadem** only does so at the permission of God [the Father] and is accountable to God for his or her actions in that role".⁶

Illegitimacy is expressed in Revelation 12 and 13 in connection with Satan or the dragon and those earthly leaders under his influence. He /they wear 7 *crowns*. The LORD Jesus, on the other hand, is the **legitimate** heir of the Father and rides a white horse in Revelation 19:12. The sword (of His mouth) in this chapter reveals His great power. As King of kings, He pronounces judgment upon wicked Babylon, led by Satan and his wicked followers on earth. Christ will reign over a Kingdom of **righteousness**, peace, and justice in the Millennial day.

In addition to the book of Revelation (chapters 12, 13 & 19), Ezekiel 21:25-26 also addresses the right to rule on earth. He does so listing **three "overturns"** of leadership in God's kingdom on the earth throughout history, and in association with the symbolic **legitimacy** of the **diadem**. It is a type for our day, when many religious leaders come in the name of the LORD. Their hearts are often far from Him, however. God's power, symbolized in the **diadem**, is removed from the wicked ones who try to usurp it. It is given to Yeshua as LORD, He whose right it is to wear.

"And thou, profane wicked *prince* of Israel, whose day is come, when iniquity shall have an end, Thus saith the Lord God; Remove **the diadem**, and take off *the crown*: this shall not be the same: exalt him that is low, and abase him that is high. I will **overturn, overturn, overturn**, it: and it shall be no more, until **he** [Christ] **come whose right it is**; and I give it him" (Ezek. 21:25-27).

These three transitions of *power* – over time - are called "**overturns**" by the Prophet Ezekiel. They include:

- (1) The LORD Jesus is the one who was to lead His people Israel originally, but the house of Jacob or Israel eventually rejected Him, desiring a mortal king like the nations surrounding God's people (see 2 Sam. 8:7).
- (2) The Gentiles then inherited God's kingdom on the earth for a time in the Christian nations of the earth. This "day of the Gentiles" has ended. The "first shall be last" and "the last shall be first".
- (3) In the end-times, many Gentile nations reject Christ by worshipping the last-days "Beast" in the book of Revelation. They have chosen the ways of spiritual Egypt and Babylon. It is a choice to worship the ways of man the false anti-Christ who is set up before them in "the grand delusion" as addressed in 2 Thess. 2:10-12.

Those who choose the ways of the world and the anti-Christ as their leader (purposely or by deception) take the "mark of the beast" (the required vaccine?) rather than "the seal of the living God" (His name on their foreheads in their hearts). According to John the Revelator, the seal of God is reserved for those who "overcome the world" (addressed seven times in Revelation chapters 2 & 3, each with a promised blessing). John tells us that they do so by keeping all "the commandments" of God, and by obtaining "the testimony of Jesus" (Rev. 12:17, 14:12, 19:10).

D. General Warnings Against Strong Wine in Scripture

Wise virgins, anciently and today, follow the counsel of God and stay away from alcoholic wine, hard liquor, and drugs. Alcohol greatly weakens one's resolve, control, and inhibitions. God desires that we be delivered from evil rather than be led into it. Some 80 Bible scriptures encourage us to abstain from the *intoxicating* effects of strong drink and *fermented wine*. Daniel was a wise, holy man who refused to be defiled by the King's "meat" and "**wine**". He preferred seed-based "pulse" and "water" instead (Dan. 1:5-17). He was blessed with great *wisdom* that exceeded the king's *wisest* advisors (magicians and astrologers) by **ten** times (see Daniel 1:10-20).

Scripture ties the intoxicating effects of strong **wine** to **murder, assassination, and defeat** (1 Kings 16:8-10, 20:12-21). It is also associated with **pride** and **immorality** among the leaders in Daniel 5:2-3 and to “**idol worship**” in verse 4. Strong, fermented **wine** is associated with being **asleep** physically or spiritually via the drunkenness of **ignorance** and **sin**. It is associated with being **unprepared** for the Savior’s Second coming return (1 Thess. 5:6-7). Through the great Prophet Isaiah, God said the “**proud drunkards** of Ephraim” would be “**trodden down**” in the last-days (Isa. 28), because they “**stumble in judgment**” and “**staggereth**” in their “**vomit**”. He added that intoxicating **wine** invites “**a perverse spirit**” (Isa. 19:14). In Isaiah chapter 5, verses 20-22, Isaiah also addresses “evil” versus “good”, and “darkness” versus “light”, comparing them to the “**strong drink**” which is “**bitter**” **wine** versus *natural new wine* that is “*sweet*”. Fermented wine is compared to “the **grapes** of gall” or *bitterness* again in Deuteronomy 32-32-34. It leads to “**rebellion**” (Deut. 29:20) and is tied to “**violence**” (Prov. 4:17). Wise King Solomon said, “the *wise* are not among **winebibbers**” (Prov. 23:19-20). We know that John the Baptist did **not** drink **wine** (Luke 1:15). Neither did those Levite priests serving at the Tabernacle. They were **not** to drink **wine** “lest ye die” (see Lev. 10:9-11; Judges 13:14; Ezek. 44:21).

Note the clear connections of the four **wine** or **vine tree** scriptures below - to the events in Eden.

Moses tied **wine** to **snakes**, stating that wine “**biteth like a serpent, and stingeth like an adder**” (Prov. 23:32).

We read that **wine** “**biteth like the cruel venom of asps**” and “**the poison of serpents**” (Deut. 23:32).

“**Wine** is “the **vine** of Sodom” (Deut. 32:32).

“All the days of his *separation* [the Nazarite] shall he eat *nothing* that is made of the **vine tree**, from the kernels even to the husk” (Num. 6:4 KJV). Compare this verse in the KJV to its Aramaic translation on the top of page 5, revealing clear ties to Eve’s corruption via the “**forbidden fruit**” in Eden.

Alcohol from the fermented **grape** is often used as a drug to **negatively effect brain function**, leading to to **modified behavior**, including a **lack of control or judgment, drunken stupors, unconsciousness, and even death**. Wine is thus often connected with **whoredoms** and **immorality** in scripture (see Deut. 23:32, Hosea 4:11, and Romans 13:13). Some believe strong wine may have been the first known **date-rape drug**.

Alcohol in *strong, fermented wine* has often been used to take advantage of others in scripture. There are at least eight examples in scripture. Three are found early in Genesis, beginning with Eve. Satan’s use of *fermented wine* there is supported by not only the Aramaic Targum, but a number of other scriptures. Eleven of them are found in Part II of this paper. In Genesis 19 we read of Lot’s two daughters who utilize *strong wine* to obtain “seed” from their father via incest. They did so without his permission and while he was unconscious.

There is also the story of Noah’s son Ham (Gen. 9:20-27). He committed sin in “uncovering the nakedness of his father”, here meaning he uncovered the nakedness (Lev. 18:7-8) of Noah’s second wife Namah (following the death of his first wife, who was Ham’s mother). Ham laid with Namah while she too was most likely drunk and unconscious (see #3 below). Namah then conceived and bore Canaan (Noah’s fourth son). Noah later cursed Canaan as the son of incest. Note the eight examples below of **take advantage** of others while they are drunk.

1. Eve was deceived by Satan, after which he encouraged her to partake of the **forbidden fruit** (in fermented grape juice or “wine”) that she might be taken advantage. She then gave birth to Cain, the firstborn son of an opposing bloodline on the earth (see Part II of this paper - Gen. 3:15 Palestinian Targum; Gen. 4:1, Palestinian and Aramaic Targums; Gen. 5:1-6 Aramaic Targum).

2. Lot’s two daughters purposely got their father **drunk**, obtaining seed through him in incest (Gen. 19:30-38).

3. Ham got his stepmother Namah **drunk** that he might have sex with her. Canaan is then born (Gen. 9:20-27; Lev. 18:8). The reality of what occurred with Namah was revealed to Noah in a dream. Clarity for this is found by consulting two extra-Biblical texts; (1) The Aramaic Targum (or “translation”) for Genesis 9, and (2) The Book of Jasher 5:12-18. In them we learn that Noah’s sons Shem and Japeth come through Noah’s first wife Naamah

(daughter of Enoch in Adam's bloodline). They are called "the children of promise" (given the priesthood). Something happened to Naamah, after which Noah took a second wife, the mother of Ham, who lays with his mother, resulting in Canaan (a fourth son to Noah). This incest is what led to the cursing by Noah.

The Canaanites were famous for venerating unusual sexual behavior (especially among some leaders) as a way to preserve and perpetuate bloodlines (a practice continuing among some elite bloodlines today). Similar incest was seen in ancient Egypt and other cultures. Nimrod, for example, married his mother Semiramis. Nimrod descended through the bloodline of Canaan. Nimrod reinstated the practices of the Nephilim (posterity of the fallen angels), including human sacrifice, etc. He attempted to create the world's first New World Order. Immorality of all kinds was and is rampant among the seed of Satan. Joshua and latter David - with the armies of Israel, were commanded to clear this unholy seed from the lands promised to Abraham's bloodline.

4. King David lied with Bathsheba, wife of Uriah. David then tried to get Uriah to drink strong **wine** that he might leave his post to go home and have sexual relations with Bathsheba, now pregnant with David's child, all to hide David's encounter with Bathsheba. Uriah valiantly refused to leave his post. King David then had Uriah placed at the front of a battle, where he was then killed (2 Sam. 11:15).

5 - 8. The Book of Mormon features three similar stories, but with a twist. In them strong **wine** is used by the those who are oppressed, as they turn to the LORD for help. They use strong wine to gain the upper hand on their enemies and escape them. In the first of these three stories, (1) Nephi obtains the brass plates from Laban while he is drunk. These plates contain scripture, including the books of Moses and other important books like Isaiah (see 1 Ne. 4:7; Isa. 49:26). A second use of strong wine is with Limhi, (2) He sends a tribute of strong wine to Lamanite captors over he and his people, to get them drunk so they can escape slavery among them (see Mosiah 22:7-10). The third use of strong wine is with Moroni, (3) where at his command, Laman (one of his soldiers) takes strong **wine** to Lamanite guards to make them drunk, allowing again the escape of oppressed people from captivity (Alma 55:8-14).

These eight examples add credibility to the extra-Biblical texts (like the Aramaic Targum) listed in Part II, which suggest Eve was taken advantage of by the serpent in Eden – with strong wine. One Apocryphal source, The Apocryphon of John (of the Dead Sea Scrolls), suggests the "**vine tree**" in Eden was the "tree of knowledge of good and evil", either a "**vine tree**" plant or a grapevine wrapping around a tree (Num. 6:4 & Ezek. 15:2 are two "**vine tree**" references). This is seen in some Catholic Cathedrals in Europe, where tall pillars (resembling tree trunks) are wrapped in a grapevine.

Besides the first corruption of the bloodline of God through **Eve** via the serpent (leading to the first murder in the Bible), there is a second later corruption, but this time of **Adam's seed**. It is well documented in the Book of Enoch. There we read of 200 "**Watcher**" angels that descended to earth on Mount Hermon in northern Israel. They **lusted** after mortal women on the earth and chose to leave their high station in the heavenly realm as "Sons of God" (advanced angels) to come down to earth to lay with women (see 2 Enoch, discovered with the Dead Sea Scrolls). These "Watchers" then made **blood-oaths** with one another to follow through with their plans, and to *support each other secretly* in their wickedness. Note that the Hebrew word "*hermon*" has ties to **making oaths**. The posterity of the union of these advanced angels and mortal women resulted in the "giants" mentioned many times in the Bible.⁷ They had special characteristics in their blood, apparently passed on to these mortals (see endnote 3).

The powerful posterity of the rebel angels ruled over and oppressed the family of man on the earth for some time, introducing great evil. They had advanced knowledge of warfare, genetics, pharmacology, sorcery, and more, all used to dominate man for their **gain** (power, sex, money, etc.). The account of one family member tied to today's "Illuminati" has ties to these "Watchers" (see endnote 7). God sent the great flood at the time of Noah to cleanse the earth of its increasing wickedness and oppression under the "giants". Latter we see God commanding Joshua and David to completely destroy the giants and the idolatry and other corruptions they introduced among the peoples in the land of Canaan. This "utter destruction" often included all men, women, and children in particular cities, suggesting corrupted bloodlines that needed cleansing. Great evils were being practiced in the choice lands promised to Abraham's seed, including Baal worship, cannibalism, child sacrifice, and every kind of sexual sin. In Matthew, Jesus prophesied that things present in the days of Noah – leading to the necessary cleansing of the Flood - would be present among us again today. He said, "But as it was in the days of Noah, so it shall be also at the

coming of the Son of Man” (see Matt. 24:37 & JST Matt. 24:41-43). It is part of a third major modification of God’s bloodline and DNA by Satan and his followers in the modern world today (see Part III).

Satan put in place false religious practices (idolatry) to tempt the people with sexual sin. This included the worship of false gods like Baal and his consort Ashteroth, tied to agricultural fertility on the earth. Child sacrifice became part of these idolatrous religious rites. It was centered upon the offering up of innocent blood (Able was the first innocent blood shed). Such things were purposeful by Satan, directly opposing the righteous offering of the Son of God for our misdeeds, an act of great love by Father, Mother, and their precious, righteous Son.

The sexual sins of surrounding cultures and their kings (who multiplied wives to themselves) were also adopted by ancient Israel, as seen with David and Solomon, kings over Israel. God addressed this corruption in Jacob 2 and 3 of the Book of Mormon, as one reason for bringing Lehi and his family to the New World before Jerusalem was destroyed. Satan also sought to corrupt the New Testament church Christ brought to the earth via the “*deeds of the Nicolaitans*”. They began utilizing the “*doctrine of Balaam*” among the Christians at Ephesus and elsewhere (see Rev. 2:1-16) to mix sexual sin with religious rites, like ancient Baal worship.

Satan made use of this unholy mix of false religion with sex once again in the 1800’s among the Cochranites of Maine and New York. It then spread to early Mormonism at Kirtland Ohio and then exploded at Nauvoo Illinois under men like Brigham Young. He took power there after Joseph Smith was murdered. Similar to Jacob’s people in the Book of Mormon (Jacob 2 & 3), the abomination of Young’s polygamy was justified by the poor examples of David and Solomon, as well as a special “priesthood” which Young claimed was had among the “patriarchal fathers”. God warned early Mormon Bishop Newel K. Whitney of this kind of religious justification for sexual sin, in D&C 117:11. Today gay, lesbian, and transgender issues dominant discussions tied to equality, choice, and freedom in the increasingly immoral western world. It is a reflection of Satan’s effectiveness in corrupting the creation power in wholesome intimacy between one man and one woman - in the current war of worship.

E. God Turns Cursed Wine into the Blessed Sacrament

In Deuteronomy 23:5 we read of how God turned cursing into blessing for those He loved. He does this repeatedly throughout scripture. One obvious example is how God turned the captivity of young Joseph sold into Egypt into a great blessing for the whole house of Israel. It was first a *physical* blessing in preservation during a time of famine. Latter the blessing was of *spiritual* salvation for mostly the Gentiles, those embracing Christianity through the blessed bloodline of Joseph’s two sons, Manasseh and Ephraim. Their patriarchal blessing through their grandfather Jacob reveals that they would preach Christ to the world in the latter-days (see JST Genesis 49).

Another **wine**-related example is how God turned the negative aspects of fermented wine throughout the Old Testament into a wonderful symbol of His love and mercy in the New Testament, when Jesus turned the Sacrament wine of the Last Supper into a symbol of His atonement. He did so on the very night He entered Gethsemane to offer up a willing sacrifice for sin on the night of Passover at full moon. His willing suffering there would continue the next day in the forced scourging at the hands of Roman soldiers, and then finally His torture and death on the cross. His death sentence originated in those Jewish leaders who were jealous of His authoritative teaching, the power in His miracles, and in the love of the people for Him. In His precious blood, symbolized in the broken bread (body) and the red wine (blood), He said, “**I make all things new**” (Rev. 21:5).

The Curse Reversed in the Sacrament Ordinance

God through His precious Son Jesus instituted the Sacrament at the Last Supper for the first time. In it He reversed the cursed effects of *strong wine*, the drug Satan used in Eden upon Eve. In the Apocryphal book known as Baruch, we read about Noah’s discovery of the vine after the flood.

“God sent his angel Sarasael, and said to him, Arise, Noah, and **plant the shoot of the vine, for thus saith the Lord: Its bitterness shall be changed into sweetness** [in the Sacrament ordinance], **and its curse shall become a blessing** [via the healing of repentance], **and that which is produced from it shall become the blood of God** [symbolically]; and as through it [the vine tree] the human race obtained condemnation, *so* again through Jesus Christ the Immanuel will they receive in Him [and His blood] the upward calling, and the

entry into paradise” (for the complete Baruch text, see #10 on pages 20-21).

As we read earlier, the cursing of *strong wine* and the drunkenness tied to it throughout scripture - was turned into blessing on three different occasions in another book of scripture, the Book of Mormon. And in each case, added portions of God’s sacred written word, essential for instruction and salvation, was involved in the three stories, as various oppressed peoples escaped the imprisonment of their drunken captors. In the first of these three examples, the righteous family of Lehi left Jerusalem for safety, venturing out into the wilderness. Before traveling too far from their first home, they were able to obtain God’s holy written word in the brass plates of Laban.

Nephi was able to get the word of God while Laban was drunk. The family took this record with them to their new homeland in the west (later becoming known as the Promised Land of America). This record contained not only their Jewish genealogy, but the prophecies of the coming Christ in the Old Testament - in books like Isaiah. The Book of Mormon has portions of 22 chapters of Isaiah in it. It also features the covenant promises God made to choice men like Joseph of Egypt, these same promises then passed down through Lehi’s seed throughout the book. Lehi’s blessed posterity (through Joseph of Egypt via Manasseh, his firstborn son) is thought to be Native Americans who are mostly concentrated in the Great Lake region of North America. They are “the Remnant of Jacob” (a blessed or chosen bloodline) who the book is written to, along with Jews and Gentiles here and around the world (see the Title Page of the Book of Mormon). The pure Sacrament ordinance instituted by Christ Himself in 3rd Nephi is part of the gospel of Jesus Christ found in the book.

F: Satan’s Beguilement of Eve

The scriptures in Part II of this paper (pages 16-21) connect the fermented fruit of the vine with the *beguilement* of Eve. To “*beguile*” another means to “Influence by trickery or flattery with ties to misleading or deluding”. It also means to “take away by cheating, deceiving, or lies”. Lucifer (who became Satan) was good-looking, intelligent or crafty, and sophisticated in his approach of Eve. Some sources say Eve became enamored with him. The fermented wine was part of Satan’s plan to beguile her into lying with him.

In the Apocryphon of John (from the Dead Sea Scrolls), we read that the “*vine tree*” was “**the tree of knowledge of good and evil**” and that its *fermented fruit* was the “**forbidden fruit**”. The introduction of a new bloodline through an alternate father – aided by fermented wine - led to long-term **enmity** between the seed of the serpent through Cain, and the seed of the woman through Seth. This is reflected in the first murder in the Bible. Eve was the mother of “all living” in both bloodlines. Seth became the *replacement* for Adam’s firstborn son Abel, murdered by Cain (Gen. 3:15). The name “Seth” means “*replacement*”. The LORD Jesus Christ as the promised Messiah, came through the **righteous bloodline** of Adam, Seth, and later David, not Cain. Jesus came to deliver mankind from sin, death, and hell, introduced into this world by the deceiving serpent.

“And I will put **enmity** between **thee** [Satan] and the woman, and between **the seed of thy son** [Cain], and **the seed of her** [and Adam’s] **sons**; and it shall be **when** the **sons of the woman keep the commandments** of the law, they will be prepared to **smite thee upon thy head**; but **when** they **forsake the commandments** of the law, thou will be ready to **wound them in their heel**. Nevertheless for them there shall be a **medicine** [via repentance and the shed blood of Jesus as the Lamb of God], but **for thee there will be no medicine** [no forgiveness for you as a son of perdition]; and they shall make a **remedy for the heel** in the days of the King Meshiha [Jesus the Christ]” (Gen. 3:15, Palestinian Targum, see also the other Aramaic Targum scriptures in Genesis on pages 16-21).

The wicked and rebellious on earth are cursed, their heads *crushed* (meaning death) with the heel of Jesus. He is also addressed above as the promised future **seed of the woman**. He heals us in the atonement. His heel was bruised in the Atonement, but it put all enemies beneath it there. The wise virgins who believe in Christ may fail from time to time, but they are only *bruised* by the serpent and his work. When one turns to God in repentance, they can be *healed* in Christ’s blood. God’s promise of only “*bruising*” (with potential healing), as opposed to “*death*” is made in the Palestinian translation of Genesis 3:15 above.

A nail was sent through our LORD’s heels when He was crucified. It is with this heel that He crushes the head of the serpent! All of us are healed through His precious blood (Isa. 53:5). His healing blood is tied to the blood of

grapes in Jacob's patriarchal blessing on his son Judah, the bloodline through which Christ was born. This blessing also addresses the LORD's triumphal entry into Jerusalem, just before He performed the atonement of us all. It also reveals that Christ is the Messiah and the coming King of kings, born of Judah, the bloodline of the Kings of Israel. Matthew makes this clear in the first of four New Testament "gospels". The book of Matthew is a bridge between the Old Testament law or covenant and the New Testament covenant. It is centered on Christ as king, the Son of David. His atonement *reversed* the actions of Satan, symbolized in the "**the blood of grapes**" shed for us! Jacob's blessing on Judah states:

"Judah, thou art he whom thy brethren shall praise: thy hand shall be in the neck of thine enemies; thy father's children shall bow down before thee. Judah is a **lion's** whelp: from the prey, my son, thou art gone up: he stooped down, he couched as a **lion**, and as an old lion; who shall rouse him up? The **sceptre** [Kingship] **shall not depart from Judah**, nor a **lawgiver from between his feet, until Shiloh** [Christ] **come; and unto him shall the gathering of the people be** [the last-days gathering of the redeemed]. **Binding his foal unto the vine, and his ass's colt** [symbol of Kingship in the Messiah, Matt. 21:2, 5, 9] **unto the choice vine; he washed his garments in wine** [in the bloodletting of Gethsemane, the scourging, and the cross], **and his clothes in the blood of grapes** [symbol of sin, death, and hell, brought here by Satan]: **His eyes shall be red with wine** [not in drunkenness, but in the wrath of God upon the evil one], and his teeth white with milk" (Genesis 49:8-12).

G. Turning Things Upside-Down

Satan makes evil good, and good things evil. He also steals and corrupts the things of God, purposely turning them "upside-down" (2 Nephi 27:27). This is true of visual symbols used in sacred architecture, like the *swastika*, the *pentagram*, and the *rainbow*. He has also usurped the *crescent moon* and *grape juice*. In Genesis, Satan took the natural "red blood of grapes", a symbol of Christ's future atonement, and with simple fermentation - used it to invite sin among Eve and Adam and the whole family of man. Yet all throughout scripture, the LORD Jesus *turns* things corrupted by Satan back to good. He said, "I make all things new" (Rev. 21:5).

Alcoholic wine can be useful as a *healing*, antiseptic agent. It was used with water and oil by the Good Samaritan (a type for Christ) to help *heal* the *bruises* on the wounded traveler's beaten body (Luke 10:34). Only John reports the miracle of Christ turning water into wine at the wedding at Cana, as *John* was responsible for revealing the *divinity* of Christ as "*the Son of God*" in his "gospel" (in connection with the **Eagle**). *Matthew* was responsible to reveal the LORD's *kingship* bloodline as "*the son of David*" (symbolized by the **Lion**). *Mark* revealed the *servant* side of Christ as "*the son*" or "*the Son of Man*" (symbolized by the **calf**, son of the **Ox**). And *Luke* revealed His human side as "*the Son of Man*"). All four roles for Jesus were placed in the first four Gospels of the New Testament, and are symbolized by the four creatures surrounding God's throne in Revelation 4:7 and Ezekiel 1:10.⁸

Our LORD may have purposely chosen His first *miracle* to be that of turning water *into wine* in connection with the wedding at Cana (some say it was His own wedding), to highlight His ability to make "**all things new**" (Rev. 21:5). His atonement reverses the effects of *sin*, *death*, and *hell* originating in Eden with a corrupted bloodline. The servants of the LORD were present at this wedding. They were being prepared for their important missions by observing the LORD's great power. His blood was shed willingly for them and for us while He hung on the cross in Jerusalem. While on this tree, He became *thirsty* and even though He was in *great pain*, He denied *relief* for both - in the sponge that was lifted up to His mouth. It was saturated with sour or *bitter wine*. Why did He refuse it to quench His thirst and deaden His pain with it? The LORD Yeshua may have made a Nazarite vow with pure and *sweet* Sacrament **wine** the night before His atonement in the Last Supper. There He vowed to **not** drink wine again with His servants - until He could do so again with them - in the Millennium (see Matt. 26:29; D&C 27; Num. 6). It will be a **joyful** reunion, much like that of the wedding feast, where He was present with His most trusted disciples. This future gathering will be centered on the **joyful** reunion of Christ - as Bridegroom - with many of most trusted servants. Later the gathered Remnant of Jacob generally, the Bride of Christ or church of believers - who survive the coming tribulation, will be united with Him too. The Holy Day known as the Feast of Tabernacles is centered on this future **joyful** reunion, a great wedding feast.

The wedding at Cana was a **joyful** event, bringing together two who had been *separate* (see John 2:1-11). The man and the woman became *one*. **Wine** was typically part of such **joyous** gatherings. Many believe this wedding was the

joining together of Christ with Mary. John *the Beloved* may have been their son. John alone tells us of the miracle of turning water to **wine** (not Matthew, Mark, or Luke). It may have been our LORD's first miracle. John wasn't yet born, but he grew up knowing the story well, as told by his mother. And he knew the divinity of His father, as he witnessed it repeatedly, being present at the cross, in Gethsemane, at His father's trial before Ciaphas. John was also present at the LORD's transfiguration, and at the Last Supper, when he (John) placed his head on His father's breast. He alone was called "Beloved" of the LORD among the disciples. John was also later translated. He is responsible for oversight of the pit holding the evil spirits released for time in the last days, a form of judgment upon those who have the mark of the beast (Rev. 9:4-5). And it is John alone who informs us of the last-days rise of the anti-Christ in the important Book of Revelation.

In the 177 total scriptures on **wine** in the Bible, 80 are tied to negative human behaviors. Only 5 of them associate wine with **joy**, a word typically associated with God's *love* or *presence*. God's servants take **joy** in knowing the LORD and serving Him. A careful reading of John's account reveals that only the *servants* (and the family) *knew* what had miraculously been done to the water - found in the six water pots (used for washing). Seeing this miracle strengthened the faith these servants already had in Jesus. Their faith was rewarded. God's word tells us that "**signs follow the believers**". They have faith and trust in the LORD (Mark 16:17). JST John 2 gives us more insights.

"His [Jesus] mother said unto **the servants**, Whatsoever he saith unto you, see that ye do it. There were set six water-pots of stone, after the manner of the purifying of the Jews . . . And he said, Draw out now, and bear unto the governor of the feast. And they bare unto him. When the governor of the feast had tasted the water which was made **wine**, (he knew not whence it was, but **the servants who drew the water knew**) the governor of the feast called **the bridegroom**, This beginning of miracles did Jesus in Cana of Galilee, and **manifested forth his glory**; and the **faith of his disciples was strengthened in him**" (JST John 2:5-11).

The LORD's special *servants*, and those who love Him, will be rewarded with His presence. It will be a most **joyous** event. Other events where **wine** was used in a positive way, includes its use by the Good Samaritan to help heal the wounds of one beaten and left to die, and Jacob's vision of the ladder at Peniel. Jacob was renamed Israel by God in this vision. He then anointed a stone pillar at Peniel with wine and oil. He erected this pillar to memorialize his *wrestle* with God there. In it Jacob saw a ladder extending to heaven, with angels going up and down on it (Gen. 28:16-22, 31:45). Jacob's raising up of an anointed pillar may have symbolized this ladder to heaven.

Countering this, many idolatrous stone pillars were erected by by Jacob's later posterity. They repeatedly participated in idolatry via Baal and Ashteroth worship, using "asherah" pillars. Baal's consort was Ashteroth. The pillar was a fertility symbol, tied to the male phallus. Wine libations and the **blood** of innocent children were offered to these false god's, symbolized in the pillars. *Sexual sin* accompanied this form of idol worship. Satan repeatedly combined idolatry, sexual sin, wine, and the innocent **blood** sacrifices of children to imitate *and* corrupt the things of God. Ancient Egyptian obelisks, May Poles, and the Washington Monument have ties to this form of idolatry and often in connection with the sun.

Today red new **wine** or the "**blood of grapes**" in the holy Sacrament or Communion rite is used to heal the breach between sinners and the Father via the pure **blood** of Christ, as symbolized in Genesis 49:11. It represents a partial fulfillment of Jacob's patriarchal blessing upon his son Judah addressed earlier (the bloodline of Israel's kings, see JST Gen. 49). The prophecy points to the triumphal entry of the King of kings as He entered into the Holy city, *descending* the Mount of Olives, and then *ascending* the Mountain of the LORD (where sat the temple). He did so riding a young, white donkey, symbol of Kingship in ancient Israel. It was the "foal of an ass" (Matt. 21:2, 5, 9). Once again we read just the latter portion of Jacob's blessing upon Judah.

The **sceptre** [Kingship] shall not depart from **Judah**, nor a **lawgiver** from between his feet, until **Shiloh** Come [in the triumphal entry of Jesus Christ into Jerusalem]; and unto **him** shall the **gathering** of the people **be** [the last-days gathering of the redeemed, those whose names are written in the Book of Life] (Gen. 49:10).

Because of our LORD's great love, mercy, and wisdom, He continually turns things of evil into good. Even some of the posterity of the evil one may turn to the LORD. Christ healed this *separation* or *breach* when His blood was willingly **sprinkled** on the ground in Gethsemane in payment for our sins. This occurred the night of Passover on

the Mount of Olives. He entered into the Garden of Gethsemane to overcome the sin introduced in the Garden. He did so willingly, without compulsion. Three scriptures tell us that He suffered there greatly, bleeding at every pore (Luke 22:44, Mosiah 3:7, D&C 19:18). The next day, He submitted to torture and execution in the brutal scourging by Roman Soldiers. They skillfully administered great suffering and blood-letting in what was called “*chastisement by scorpions*” (1 Kings 12:11; 2 Chron. 10:11); a special type of whipping potentially involving a three-pronged whip, with sharpened bits of bone or metal. The LORD’s blood literally **poured out** on the ground. Latter that day he was brutally tortured until death in the crucifixion. There blood from His hands and wrists was **smear**ed upon the wooden crossbeam He carried to Golgotha. This crossbeam was was most likely lashed to a *tree*.

Sprinkling, pouring out, and smearing are the three ways in which the High Priest in ancient Israel (representing Christ as the Great High Priest) used **blood** inside the Tabernacle on the Day of Atonement - to remove **sin** from himself and from the children of Israel generally (at least those who would repent). Half of all references tied to the Savior’s “cross” in the New Testament call it a “**tree**” On it the effects of the “**vine tree**” in Eden were reversed by the Son of God. He makes all things **new** (Rev. 21:5).

Because of pride, hatred, and rebellion, Satan brought sin, death, and hell into this world via the choice of Eve and Adam in partaking of the **forbidden fruit**, the fermented **fruit of the vine**. It weakened resolve, control, and judgment of these two important souls. Their transgression led to banishment from Eden, hard work, and eventual death. It was also turned to **joy** in much of their posterity.

H. Seed as Fruit

The Hebrew meaning of “**fruit**” and “**seed**” in scripture is primarily tied to “*offspring*”, “*children*”, or “*posterity*”. They are a great blessing to most women in scripture. Being “barren” was a curse. Note the meaning behind the Hebrew words “**fruit**” and “**seed**” below.

פֶּרִי p^{er}riy, per-ee’; **fruit** (literally or figuratively):—bough, (first-) fruit(-ful), reward, produce (of the ground), **offspring, children, progeny (of the womb)**, (of actions) (fig.)

זֶרַע zera‘, zeh’-rah; **seed**; figuratively, fruit, plant, sowing-time, **posterity**:—× **carnally, child, seed, sowing, seed** (-time), sowing-time, **a sowing as seed semen virile, offspring, descendants, posterity, children**, of moral quality, fruitful, a practitioner of righteousness.

It was in the 4th and 5th century BC (the time of the building of the temple by Zerubbabel) that the Aramaic Targum was produced for the average Israelite returning from the Babylonian captivity. In it we read of Eve’s *beguilement* by the serpent and the birth of Cain, separate from Adam’s **seed**. *Enmity* soon developed between the offspring of the two different fathers, all in fulfillment of the Aramaic version of Genesis 3:15 (see page 16, also Gen. 4:1-2, and 5:1-6 of the *Aramaic and Palestinian Targums*, edited by Zen Garcia, Sacred Word Publishing, in Part II hereafter).

The credibility of the Eden story with its two **seedlines** in the Aramaic Targum is greatly enhanced by the fact this same Aramaic translation also *restores* Christ as “**the Word**” (of Father) and *the Creator* in the **creation** account in Genesis. There we find **251** total references to “**the Word**” or “**the Word of the Lord**” as a separate being from God the Father. In them we see the role of Jesus as **Creator** under the direction of the Father. There are only a few references to Christ as “**the Creator**” in our current 1611 *King James Version* of the Bible and they are in the New Testament. The most common name for the LORD Jesus in the Aramaic Targum is “**the Word**” of the LORD God (the Father). Of 251 references to Jesus in the Aramaic Targum, 15 are name-titles for Him.

Like the Aramaic Targum, our LORD Jesus is called “**the Word**” in John 1:1. There we read that Jesus was with the Father from the beginning. Most references to Jesus in the Old Testament have been edited out of it by Jewish scribes, as they did not accept Him as Creator, nor Redeemer. His role as the Messiah is clearly represented in Isaiah

53, a chapter ignored in Synagogue readings by Rabbi's - because of its clear symbolic ties to the Jesus of Christians.

The mostly unknown 1867 **JST** (Joseph Smith Translation of the Bible) reveals a similar, detailed *restoration* of Jesus Christ as **Creator**, to the early 1611 KJV Genesis chapters. In the first 8 chapters of Genesis alone, we find 39 references to Jesus the Christ (many as **Creator**). We also see 18 different name-titles for Him there (see the next page). Many other insights tied to our LORD Jesus are provided in this unique 1867 "translation", one of the oldest of some 271 different translations of the Bible. The 18 different name-titles for Yeshua or Jesus Christ in the first 8 chapters of JST Genesis, include those on the next page:

Part II: Scriptures Revealing the Two Opposing Seedlines – *Witnesses #'s 2 – 12 (pages 18-24).*

Additional sources of scripture (#'s 2-12 hereafter) provide strong support for the introduction of the serpent's bloodline on earth via the combination of Satan's lies *and* the forbidden fruit of the vine (addressed in Part I). They include verses in the 1611 *King James Version* of the Bible (KJV), the 515 BC *Aramaic Targum*, *Apocryphal* sources like the *Book of Enoch*, and non-Biblical sources like the 1867 *JST* (the *Joseph Smith Translation* of the Bible, also LDS known as the Book of Moses), and other sources. We begin with the words of Moses.

1. **Part I**, featured previous coverage of **Grapes**, **Nazarites**, the **Diadem**, etc. on pages 4-17.

Eleven Additional Witnesses for a Second Bloodline through Eve (pages 18-23)

2. **Moses** *the Prophet writer of the first 5 books of the Bible (Genesis, Exodus, Leviticus, Numbers & Deuteronomy) – the Torah*

Genesis 3:15 *Palestinian Targum – Two "Seed" or "Bloodlines"* "And I will put **enmity between thee** [Satan] **and the woman, and between the seed of thy son** [Cain], **and the seed of her** [and Adam's] **sons**; and it shall be **when the sons of the woman keep the commandments** of the law, they will be prepared to **smite thee** [Satan] **upon thy head**; but **when they forsake the commandments** of the law, thou will be ready to **wound them in their heel**. Nevertheless for them there shall be a **medicine** [via repentance & the blood of Christ - the Lamb of God], but **for thee there will be no medicine** [no forgiveness for you as a son of perdition]; and they shall make a **remedy for the heel** in the days of the King Meshiha [Jesus Christ]". Compare to the KJV.

Christ and His atoning blood is that **remedy**, symbolized in "**the blood of grapes**" of the Holy Sacrament (see Gen. 49: 9-12). It symbolizes His *pure* blood. Unleavened bread of the 7-day feast after Passover, is bread (His flesh) made without leaven (sin), representing His *pure* broken body.

A. The "**seed of the woman**" refers to "all living" or humanity in general, and specifically those redeemed by Christ and His blood. Most agree that this phrase also points to Christ as the "seed of the woman" who came to earth to redeem all those who would look to Him for salvation (literal physical seed and spiritually adopted seed).

B. The **bruised heel** of the seed of the woman (Christ at His crucifixion), points to the nail driven through both heels of our Savior there.

C. The **bruised or crushed head** of the serpent speaks to the final judgment of Satan and those following him in the latter-days. These followers include religious leaders (wolves in sheep's clothing) who use the people for gain rather than leading them to Christ – the Good Shepherd (John 10). Jesus called the false leaders of his day "the children" or "**seed of the devil**" (see John 8:44). In Isaiah 28 we learn that great wickedness and pride will exist among Ephraim (the **drunkard**) in the last-days because they stray from truth. Isaiah describes Israel's watchmen as blind, ignorant, dumb, greedy and asleep (in their drunkenness). "They are shepherds that cannot understand; they all look to their own way, everyone for his **gain**, from his quarter. Come ye, say they, I will fetch **wine**, and we will fill ourselves with **strong drink**; and to morrow shall be as this day, and much more abundant" (Isaiah 56:10-12).

Genesis 4:1 *Palestinian Targum – Genealogy of Cain* “And Adam **knew** Hava [Eve] his wife, **who had desired the Angel** [under influence of the fermented grape]; **and she conceived, and bare Cain**; and she said, I have acquired a man, the Angel of the Lord. And she added to bear from her husband **Adam his twin, even Habel**”.

Genesis 4:1 *Aramaic Targum (Jonathan) – Genealogy of Cain* “And Adam knew his wife Eve, **who was pregnant by Sammael** [Satan], **and she conceived and bare Cain**, and **he was like the heavenly beings**, and **not like earthly beings**, and she said, **I have gotten a man from the angel of the Lord**”.

Genesis 5:1-6 *Aramaic Targum – Genealogy of Adam & Seth (Man)* “This is the book of **the genealogy of Man**. In the day that the Lord created man, **in the likeness of the Lord**. He made him. Male and female He created them, and **blessed them in the name of His Word**, and He called their name **Man** in the day they were created. And Adam lived a hundred and thirty years, and **begat Sheth** [Seth], **who had the likeness of his image and of his similitude: for before had Hava** [Eve] **born Cain, who was not like to him**; and **Habel was killed by his hand. And Cain was cast out; neither is his seed genealogized in the book of the genealogy of Adam. But afterwards there was born one like him, and he called his name Sheth**”.

JST Genesis 5:6-18, 33-39 / Book of Moses 5:18-21 & 47-52 This is Joseph Smith’s re-translation (via revelation) of Genesis, published in 1867 by his firstborn son, Joseph Smith III, then President of the Re-organized Church of Jesus Christ of Latter-day Saints (now the Community of Christ). The 500 page manuscript for the JST did not go west with Brigham Young and the Mormons but remained in the hands of Emma Smith (wife of Joseph Smith). A much smaller portion of this entire Bible translation is called the Book of Moses, used by Mormons (see chapter 5:18-33, 47-52). The verses below address two important points; (1) Abel’s choice to follow **God’s will** over his own will in the innocent animal sacrifice pointing to the Lamb of God – Jesus. Abel was “a keeper of the sheep” and offered up to God “the firstlings of his flock”. And (2) The covenant Satan made with Cain secretly, which secrecy spread among men and maintained today via Free Masonry and other secret societies opposing God.

“**And Cain loved Satan more than God**. And Satan commanded him, saying: Make an offering unto the Lord [which I Satan will choose for you]. And in process of time it came to pass that **Cain brought of the fruit of the ground** [perhaps **grapes** – the forbidden fruit, along with others] an offering unto the Lord [this was Satan’s choice through Cain, *not* God’s will]. And Abel . . . brought of **the firstlings of his flock**, and of the fat thereof [he did so following **God’s will**, *not* his own (JST 4:5-7 & 5:5-7 RLDS / Moses 5:18-21 LDS)]. And the Lord had respect unto Abel, and to his offering [as it reflected God’s will]; But unto Cain, and to his offering, he had not respect.

Now Satan **knew this**, and it pleased him [knowing it would be rejected by God]. And Cain was very wroth, and his countenance fell. And the Lord said unto Cain: Why art thou wroth? Why is thy countenance fallen? If thou doest well [by following my counsel], thou shalt be accepted. And if thou doest not well, sin lieth at the door, and Satan desireth to have thee; and except thou shalt **hearken unto my commandments**, I will deliver thee up, and it shall be unto thee according to his desire. And thou shalt rule over him; For from this time forth thou shalt be the father of his lies; thou shalt be called Perdition; for thou wast also before the world. And it shall be said in time to come—That these abominations were had from Cain; for he rejected the greater counsel which was had from God; and this is a cursing which I will put upon thee, except thou repent.

And Cain was wroth, and listened not any more to the voice of the Lord, neither to Abel, his brother, who walked in holiness before the Lord. And Adam and his wife mourned before the Lord, because of Cain and his brethren. And it came to pass that Cain took one of his brothers’ daughters to wife, and **they loved Satan more than God**. And Satan said unto Cain: **Swear unto me by thy throat**, and if thou tell it thou shalt die; and **swear thy brethren by their heads**, and by the living God, that they tell it not; for if they tell it, they shall surely die; and this that thy father may not know it; and this day **I will deliver thy brother Abel into thine hands. And Satan sware unto Cain that he would do according to his commands. And all these things were done in secret**.

And Cain said: Truly I am Mahan, the master of this great **secret, that I may murder and get gain**. Wherefore Cain was called Master Mahan, and he gloried in his wickedness. And Cain went into the field, and Cain talked with Abel, his brother. And it came to pass that while they were in the field, Cain rose up against Abel, his brother, and slew him. And Cain gloried in that which he had done, saying: I am free; surely the flocks of my brother falleth into my hands” . . . (Moses 5:18-33).

“And Lamech said unto his wives, Adah and Zillah: Hear my voice, ye wives of Lamech, hearken unto my speech; for I have slain a man to my wounding, and a young man to my hurt. If Cain shall be avenged sevenfold, truly Lamech shall be seventy and seven fold; For **Lamech having entered into a covenant with Satan**, after the manner of Cain, wherein he became Master Mahan, master of that great **secret which was administered**

unto Cain by Satan; and Irad, the son of Enoch, having known their **secret**, began to reveal it unto the sons of Adam; Wherefore Lamech, being angry, **slew him, not like unto Cain, his brother Abel, for the sake of getting gain, but he slew him for the oath's sake.**

For, from the days of Cain, there was a **secret combination**, and their works were in the dark, and they knew every man his brother. Wherefore the Lord acursed Lamech, and his house, and all them that had covenanted with Satan; for they kept not the commandments of God, and it displeased God, and he ministered not unto them, and their works were abominations, and **began to spread among all the sons of men . . .**" (Moses 5:47-52).

3. James *the Just, half-brother of Christ, first Bishop over Jerusalem*

Throughout scripture the "woman" is typically tied to Israel and the modern Christian church – the Bride of the Lamb. In the Old Testament, this Bride was often "unfaithful" to God as her husband. Too often Israel went "a whoring after other gods" because of the influence of surrounding *corrupt* cultures in Canaan. Symbolizing God's continual mercy, the Prophet Hosea was commanded by Him to take a prostitute as his wife. This dramatically emphasized Israel's frequent **idolatry** and **unfaithfulness**. In His mercy, God welcomes her back as she repents.

Joseph, the stepfather of Christ in the New Testament, symbolizes this Bridegroom husband too. He found out that his supposed virgin wife Mary was pregnant. Because an angel intervened, telling him that the child was of God, he honored his espousal to her. Note the Apocryphal source below in connection with this story.

The Proto-Evangelium of James – *Joseph compares the story of Eve with his espoused wife* "Joseph came . . . and found her [Mary, his espoused future wife] **great with child** . . . for I received her out of the temple of the Lord my God a **virgin**, and have not kept her safe. Who is he that hath ensnared me? Who hath done this evil in mine house and hath **defiled the virgin? Is not the story of Adam repeated in me?** For as at the hour of his giving thanks **the serpent came and found Eve alone and deceived her, so hath it befallen me also . . .** But she [Mary] wept bitterly, saying: **I am pure** and I know not a man. And Joseph said unto her: Whence then is that which is in thy womb? and she said: As the LORD my God liveth, I know not whence it is come unto me".

4. Jesus *the Christ - Creator, Redeemer, Healer, Judge & King of kings*

John 8 KJV "Ye seek to kill me . . . and ye do that which ye have seen with **your father** . . . If ye were Abraham's children, ye would do the works of Abraham . . . [yet] ye seek to kill me, a man that hath told you the truth. Ye do the deeds of **your father** [lying & murdering to get gain]. . . If God were **your Father**, ye would love me . . . Ye are of **your father the devil**, and **the lusts of your father** ye will do. He was a **murderer from the beginning**, and abode **not in the truth**, because there is **no truth in him**. When he speaketh a **lie**, he speaketh of **his own**; for **he is a liar and the father of it** . . . He that is of God heareth God's words" (John 8:37-44, 47).

Matthew 3:7, KJV – Jesus addresses the "wrath to come" upon the "generation of **vipers**"

Matthew 13:36-43, KJV – *Parable of the Wheat and the Tares* "Then Jesus sent the multitude away, and went into the house: and his disciples [close followers] came unto him, saying, Declare unto us **the** [meaning] **parable of the tares of the field**. He answered and said unto them, He that soweth the **good seed** is the Son of man; The field is the world; **the good seed are the children of the kingdom**; but **the tares are the children of the wicked one**; **The enemy that sowed them is the devil**; the harvest is the end of the world; and the reapers are the angels. As therefore the **tares** are gathered and burned in the fire; so shall it be in the end of this world. The Son of man shall send forth his angels, and they shall gather out of his kingdom all things that offend, and them which do iniquity; And shall cast them into a furnace of fire: there shall be wailing and gnashing of teeth. Then shall the **righteous** shine forth as the sun in the kingdom of their Father. Who hath ears to hear, let him hear."

Matthew 23, KJV – blind guides, ye **serpents**, generation of **vipers**, how can ye escape the damnation of **hell**

Matthew 24:37-39, KJV – Troubles like those in the days of Noah are coming again. Many believe this is the potential rising up of the seed-line of the Watchers once again in our day. "But as the days of Noah were, so shall also the coming of the Son of man be" (v. 37).

Matthew 25:31-34, 41, KJV – Dividing of the Sheep & the Goats “When the Son of man shall come in his glory, and all the holy angels with him, then shall he sit upon the throne of his glory: And before him shall be gathered all nations: and **he shall separate them one from another, as a shepherd divideth his sheep from the goats:** And he shall set **the sheep on his right hand, but the goats on the left.** Then shall the King say unto them on his right hand, Come, ye **blessed of my Father,** inherit the kingdom prepared for you from the foundation of the world . . . Then shall he say also unto them on the left hand, Depart from me, **ye cursed,** into everlasting fire, **prepared for the devil and his angels”.**

5. Paul *the Apostle*

2 Cor. 11:2-3, KJV “For I am jealous over you with godly jealousy: for I have **espoused you to one husband,** that I may present you as a **chaste virgin** to Christ. But I fear, lest by any means, as **the serpent beguiled Eve** through his subtilty, so your minds should be **corrupted** from the simplicity that is in Christ”.

6. John *the Beloved Apostle*

Speaking to the wicked leaders in Israel who sought to kill Jesus, he said to them:

John 8:38, 42 & 45 “I speak that which I have seen with *my* Father; and ye do that which ye have seen with *your* father . . . If God were *your* Father, ye would love me: for I proceeded forth and came from God . . . Ye are of **your father the devil,** and the lusts of *your* father ye will do. **He was a murderer from the beginning,** and abode not in the truth, because there is no truth in him. When **he speaketh a lie,** he speaketh of **his own:** for he is a liar, and the father of it.”

1 John 3:1-12, Those Committing Sin are of the Devil, like Cain son of the Wicked One Behold, what manner of love the Father hath bestowed upon us, that we should be called **the sons of God:** therefore the world knoweth us not, because it knew him [Christ] not. Beloved, now are we the sons of God, and it doth not yet appear what we shall be: but we know that, when he shall appear, we shall be like him; for we shall see him as he is. And every man that hath this hope in him purifieth himself, even as he is pure. Whosoever committeth sin transgresseth also the law: for sin is the transgression of the law. And ye know that he was manifested to take away our sins; and in him is no sin. Whosoever abideth in him sinneth not: whosoever sinneth hath not seen him, neither known him. Little children, **let no man deceive you:** he that doeth righteousness is righteous, even as he is righteous. **He that committeth sin is of the devil; for the devil sinneth from the beginning.** For this purpose the Son of God was manifested, that he might destroy the works of the devil. Whosoever is **born of God** [made new in Christ, receiving the Holy Ghost] doth not commit sin; for **his seed** remaineth in him: and he cannot sin, because he is **born of God.** **In this the children of God are manifest, and the children of the devil:** whosoever doeth not righteousness is **not** of God, neither he that loveth **not** his brother [the 2 great commandments]. For this is the message that ye heard from the beginning, that we should love one another. **Not as Cain, who was of that wicked one,** and slew his brother. And wherefore slew he him? Because his own works were evil, and his brother's righteous”.

Revelation 2:9 / 3:9 – False Edomite Jews are the Canaanites “I know thy works, and tribulation, and poverty, (but thou art rich) and I know the blasphemy of them which **say** they are Jews [bloodline], and **are not,** but **are the synagogue of Satan**” (Rev. 2:9). / “Behold, I will make them of the **synagogue of Satan,** which **say** they are Jews, and **are not,** but do **lie;** behold, I will make them to come and worship before thy feet, and to know that I have loved thee” (Rev. 3:9).

Many of the “fake Jews” are thought to be Edomite Jews of Canaanite lineage.

The Apocryphon of John in the Dead Sea Scrolls connects **wine** to the *beguilement* of Eve. In it we read that the “vine tree” was “**the tree of knowledge of good and evil**” and that its *fermented fruit* was the “**forbidden fruit**”.

7. Daniel *the Prophet*

Daniel 2:43, the Mixed Seed of the Sons of God & Man “And whereas thou sawest iron mixed with miry clay, **they shall mingle themselves with the seed of men:** but they shall not cleave one to another, even as iron is not mixed with clay”.

According to the Jamieson-Fausset-Brown Bible Commentary, “The ‘mingling with the seed of men’ (Dan. 2:43) seems to refer to Gen. 6:2, where **the marriages of the seed of godly Seth with the daughters of ungodly Cain** are described in similar words.” *See also Daniel 9:24.*

8. Micah *the Prophet*

Micah 3:1-4 – *Those of the Seed of Satan Offer Tortured Human Sacrifices, drink blood & eat flesh* “And I said, Hear, I pray you, O heads of Jacob, and ye princes of the house of Israel; Is it not for you to know judgment? Who hate the good, and **love the evil**; who **pluck off their skin** from off them, and **their flesh from off their bones**; Who also **eat the flesh of my people**, and **flay their skin from off them**; and they break their bones, and chop them in pieces, as for the pot, and as flesh within the caldron”.

9. Enoch *the Prophet*

Book of Enoch 86:1-6 (*called the “Dream Vision”*) – *Descent of 200 Watcher Angels & Sex with Mortal Women* “And again, I looked with my eyes as I was sleeping, and I saw Heaven above, and behold, **a star fell from Heaven**, and it arose and ate and **pastured amongst those bulls**. And, after this, I saw the **large** and the **black bulls**, and behold, **all of them changed their pens, and their pastures, and their heifers**. And they began to **moan, one after another**. And, again, I saw in the vision and looked up at Heaven, and behold, I saw **many stars, how they came down**, and were **thrown down from Heaven to that first star, and fell amongst those heifers and bulls**. They were with them pasturing amongst them. And I looked at them and saw, and behold, **all of them let out their private parts**, like horses, and **began to mount the cows of the bulls**. And they **all became pregnant** and bore elephants, camels, and asses. And all the bulls were afraid of them, and were **terrified** in front of them. And they began to bite with their teeth, and to **devour**, and to **gore** with their horns. And so they began to **devour those bulls**, and behold, all the sons of the Earth began to tremble and shake before them and to flee.”

10. Noah *the Prophet's Words according to Baruch - aid to the Prophet Elijah*

Baruch 4:1-17 – *The Grape (via its fermented wine) is the Forbidden Fruit* “And I [Baruch] said, I pray thee show me **which is the tree which led Adam astray**. And the angel said to me, **It is the vine, which the angel Sammael planted**, whereat the Lord God was angry, and **He cursed him and his plant, while also on this account He did not permit Adam to touch it**, and therefore **the devil being envious deceived him** [Adam] **through his vine**. And I Baruch said, Since also **the vine has been the cause of such great evil**, and is under judgment of the curse of God, and *was* the destruction of the first created, how is it now so useful? And the angel said, Thou askest aright. When **God caused the deluge upon earth, and destroyed all flesh**, and four hundred and nine thousand giants, and the water rose fifteen cubits above the highest *mountains*, *then* the water entered into paradise and destroyed every flower; but it removed wholly without the bounds **the shoot of the vine** and cast it outside.

And when the earth appeared out of the water, and Noah came out of the ark, he began to plant of the plants which he found. But **he found also the shoot of the vine**; and he took it, and was reasoning in himself, What then is it? And I came and spake to him the things concerning it. And he said, Shall I plant it, or what *shall I do*? Since Adam was destroyed because of it, let me not also meet with the anger of God because of it. And saying these things he prayed that God would reveal to him what he should do concerning it. And when he had completed the prayer *which lasted* forty days, and having besought many things and wept, he said: Lord, I entreat thee to reveal to me what I shall do concerning this plant. But God sent his angel Sarasael, and said to him, Arise, **Noah**, and **plant the shoot of the vine, for thus saith the Lord: Its bitterness shall be changed into sweetness, and its curse shall become a blessing, and that which is produced from it shall become the blood of God** [the Sacrament]; and as through it the human race obtained condemnation, *so* again through Jesus Christ the Immanuel will they receive in Him the upward calling, and the entry into paradise.

Know therefore, Baruch, that **as Adam through this very tree obtained condemnation**, and was divested of the glory of God, so also **the men who now drink insatiably the wine which is begotten of it, transgress worse than Adam**, and are far from the glory of God, and are **surrendering themselves to the eternal fire**. For (no) good comes through it. For those who drink it to surfeit do these things: neither does a brother pity *his* brother, nor a father *his* son, nor children *their* parents, but **from the drinking of wine come all evils, such as murders, adulteries, fornications, perjuries, thefts, and such like**. And **nothing good** is established by it.”

11. Lamech son of Enoch

Genesis Apocryphon, column 2 - Lamech worried that his wife was defiled by one of the Watchers Then I considered whether the **pregnancy** was due to the Watchers and Holy Ones, or (should be ascribed) to the Nephil[im], and I grew perturbed about this child. Then I, Lamech, became afraid and went to Batenosh, [my] w[ife] ... saying, "Decl[are] [to me] by the Most High, by the Lord of Greatness, by the E[ternal] King [whether the child comes from the] heavenly beings! Everything will you truthfully tell me, whether [... ...] you will tell me without lies: is this [... ... swear] by the Eternal King until you speak truthfully to me and not with lies [...]." Then Batenosh my wife spoke with me forcefully. [She we]pt and said, "O my brother and master, recall for yourself my pregnancy [... ...] marital relations, and my breath within its sheath (?). (Can) I truthfully [tell you] everything?" [... ...] then I was perturbed even more.

When Batenosh my wife noticed that my face had changed (its) expression [... ...] then she gained control of her emotion(s) and spoke with me. She said to me, "O my master and [brother, recall for yourself] my pregnancy. I swear to you by the Great Holy One, by the Ruler of Hea[ven] that **this seed is yours**, that this pregnancy is from you, that from you is **the planting of [this] fruit** [and that it is] not from any alien, or from any of the Watchers, or from any heavenly being. Why has the appearance] of your face changed like this upon you? And (why) is it disfigured, and your spirit dejected like this? [... for I] tell you (this) truthfully. Then I, Lamech, hurried to Methuselah, my father, and [communicated] all this to him [so that he might consult Enoch] his father, and come to know everything with certainty from him since he is loved and fav[ored] by God, and with the Holy Ones] has his lot been apportioned, and (hence) they (God and the angels) reveal everything to him. When Methuselah heard [these things], he hurried to Enoch, his father, to learn from him the truth of the whole matter [... ...] his approval, and he (Enoch?) had previously gone to Parvayyim.

12. The Kolbrin Bible

Chap. 5, Wine administered to Take Advantage of Others "As the days passed they dallied longer together and Lewid talked of things Maeva had not heard before. She felt a stirring in her blood but did not respond or heed his temptations, because of the things which were forbidden. So Lewid went to the Moonmother, wise woman of the Yoslings, and telling of his desires beseeched her to help him. The Moonmother gave him two apples containing a vile substance which they had drawn through their stalks; this Lewid gave to Maeva who then became helpless in his hands. They met again after this, for Maeva became enamoured towards Lewid, but it happened that she became ill with a strange sickness and was afraid. Then Dadam became ill and Lewid also, and Lewid said to the woman, "You must obtain the pure essences from within the Sacred Enclosure, and Setina, the Moonmother, will prepare an **elixir** which will cure us". This he said because none of his kind had ever been able to obtain the Sacred Substances, though they had always coveted what had been denied them. Now, because of her frailty, the woman was pliable in his hands and Lewid seized the opportunity. To achieve his ends **Lewid gave Maeva a potion** which had been prepared by the Moonmother and **she administered this to Dadam** and those with him, **by guile and deceit, so that they fell asleep.**

While they slept Maeva stole from the Sacred Substances and took them to Lewid who gave them to the Moonmother, and **she made a brew**. Part of this was given to Maeva and the rest was drunk by the Yoslings, from their awful ankital **during their night rites. When the morning came they were all smitten with grievous pains, and before the sun set that day all the Yoslings were stricken with a sickness such as they had not known before. Maeva took what had been given to her and finding Dadam laid low in his bed gave him a draught from her vessel, though she had to use womanly wiles to get him to drink it. She drank the remainder and they both slept. But when they awoke in the morning both were suffering pains and this was something they had not known before. Dadam said to the woman, "What have you done, for what has happened to us cannot be unless the things which are forbidden have been done"**. The woman replied, "Lord, I was tempted and I fell, I have done that which is forbidden and unforgivable". Dadam said, "I am bound by duty to do certain things, but first let us go into the Gisar to the place called Bethkelcris, where I will seek enlightenment". So they went there together and stood before the shrine beneath the Tree of Wisdom. There they were filled with an inflowing vision, seeing themselves as they were and as they should have been, and **they were ashamed**. He because he had not followed the proper path of a man and she because of her falsity. There, in the reflecting mist, **the contamination of the woman was revealed**, and the man's heart shriveled within him like a flower licked by flame.


Then they saw a great Spirit being materializing in the reflecting mist and he said to them, "Woe to you and your house, for **the greatest of evils has befallen the race of The Children of God and it is defiled**. The heritage of Kadamhapa is lost. The **fetid flow defiling the woman results from the incompatible intermingling**, but it is not all, for sicknesses and diseases are also generating from the ferments of the **impure implantation**". Dadam said, "The fault is with the woman, wherefore should I suffer?" The Spirit being replied, "Because you two are now as one the cankerworms of disease and sickness strike both equally, but you shall not again defile this place. Henceforth, the misty veil becomes an impenetrable barrier severing our two realms from each other, so they can no longer be easily spanned. Between us there will now be no means of communication. Henceforth, man and woman, fated to unite in love divine, shall be divided and set apart, though ever yearning reunion. They may cleave one to the other, seeking the unity which will rekindle the flame, but unless their efforts transcend the limitations of earthly things they will be in vain."

Part III: The Return to 3-Strands of DNA (pages 24-29)

God the Father creates by organizing existing matter. Mother provides life to it. Satan does not create. He provides corruption and death. As addressed at the start of this paper, Lucifer's banishment from heaven - because of pride and jealousy, resulted in him becoming Satan. His goal then became usurping God's throne (Isa. 14:9-15) and corrupting all things in God's pure creation. This corruption has included the pure bloodline that God introduced into the veins of Adam and Eve, a bloodline believed to feature 3-strands of DNA, not just the 2 scientists say we have today. Because of love, Father, Mother, and their Firstborn Son have provided a number of ways to reverse the seeds of death introduced by the evil one. This is addressed at the end of this final section of the paper.

The Cross-Shaped Laminin Molecule

In the well-researched "Genome Project," scientists have discovered that *laminin* holds the genes of our DNA together. Scientists have detected 2 visible strands of DNA spiraling around one another. They hold the genetic code causing one to have blue eyes or brown, light or dark skin, and baldness among some men. These and other things are passed down from fathers and mothers to children.



Left, the cross-shaped, glue-like substance known as Laminin holds our DNA together. It is believed to have 3 chains or "strands". The 2 illustrations left and middle feature the "A" chain in white or blue. They are symbolically tied to the greater light of those who are "born again" in Christ Jesus; At Right we see the Caduceus, symbol of the health profession and the Chakra energy centers surrounding the human spinal column. The 2 serpents may be tied to the battle between the 2 serpents in the first Passover (the first 2 of 12 miraculous signs there). It was a battle between the living God and His great power, and the false idols of the Egyptians. Later, Moses raised up a serpent on a pole, symbolizing the future Son of God as Redeemer being raised up on a pole in the Atonement. His pure blood - shed for us - provides healing, reversing the effects of sin, death, and hell - introduced by the opposing serpent who beguiled Eve in Eden.

Many believe we have 3 strands of DNA, forming a unique *cross*-shaped molecule that serves as a *signature, mark, seal, or sign* of God and His love for us. This love is seen in the Atonement of Christ Jesus – **the Only Begotten Son** of God the Father and the mortal mother Mary. The mostly invisible 3rd strand of DNA is a **light**-based strand, centered between the two other spiraling strands. Some suggest that these 2 strands resemble 2 serpents spiraling around a central pole. Their centrality in light is surrounded by the swirling energy of 7 Chakras or energy centers. The center strand appears to be strengthened by additional light when one turns fully to God. It is a *mark* of where one's heart is, a *sign* of who they are and who they worship. At the cellular level, the light-based central axis of the **cross**-shaped laminin molecule, may also represent the *name* of God and a kind of *seal* He places us when we submit our **will** to **His** (see the following 7 scriptures; Matt. 6:10; Mosiah 5:5; John 4:34, 5:30, 6:38-40, 7:17, 8:28-29). This is apparent as we come to Him in as Savior in repentance with a broken heart and contrite spirit. Opposing this *mark, sign, name* or *seal* - is the *mark* of the beast, found upon those who follow him or embrace the ways of the world.

Three Bloodline Corruptions

At least 3 *major* corruptions of God's pure bloodline have occurred on the earth. As we have seen, the 1st was Satan's deception and corruption of Eve in Eden, leading to the birth of Cain, who eventually murdered Abel (Adam's firstborn son as heir) for "gain". He sought Abel's flocks. The 2nd great corruption of blood was with the descent of 200 Watchers or "fallen angels" to earth. They took wives of mortal women, resulting in "the giants" mentioned some 24 times in the Bible (see endnote 7). They corrupted and in some cases enslaved Adam's posterity on earth, also for "gain". The great Flood tied to Noah was sent to cleanse the earth of its many pollutions and corruptions, including the modified bloodline of those promoting wickedness.

The 3rd major blood corruption is occurring now and is being led by the descendants of Cain and the Watchers. They wish to modify our DNA. Many of them are part of the "Illuminati" or the "illuminated elite". They control much of the world for "gain" - power, money, and sex; the 3 things Satan promises those who follow him. He was a liar and murderer from the beginning. He seeks our destruction.

In Matthew 24, Jesus prophesied that "things" present in the days of Noah – leading to the necessary **cleansing** of earth via the Flood - would be present among us again today. He said, "But as it was in the days of Noah, so it shall be also at the coming of the Son of Man" (JST Matt. 24:41). The great wickedness in Noah's day, now among us again, includes not only widespread sin, but the use of genetics to modify DNA, along with the potential rising up of Nephilim-like beings who desire to control us. This will result in another great cleansing of the earth and its wickedness, but this time by fire. Their **genetic modification** of our DNA involves many things we take into our bodies. Many of these things are or will be forced upon us by those leading out in government, the health and food industries, education, entertainment and media, etc. Some are used as bio-weapons.

John the Revelator may address the corruption of our blood *and* its DNA in Revelation chapter 13, verses 17-18. There he asserts that the number 666 is "the *mark* of the beast." The number 666 is 2/3rds of a whole of 1000 or **66.6%** of 100%. This may be a numerical marker for lower-light individuals with only 2 visible strands of DNA, that apparent among those rejecting Christ. They are not "born again" in Him. They instead embrace the ways of the world (or "Babylon"), resulting in a weak, nearly invisible 3rd strand of DNA. Many of them, along with unsuspecting Christians may willingly embrace the modification of their DNA in the near future.

Evil and designing men among the Illuminati wish us to worship their "father" Satan. The Bible number 666 – "the *mark* of the beast" - may be a DNA-level *sign, seal, or mark* of the more carnal nature of man *and* those choosing to follow the evil one, knowingly or unknowingly. This *mark* may be enhanced among us by the assimilation of nano-bots into our bodies. They further effect change in our biology, health, and attitude via collective modification of genetics, vaccines, and the perhaps the electronics of the 5G wifi signal. The greatest hope we have in fighting off these changes is turning fully to God.

Born Again with Cleansed Blood

The greatest weapon against darkness is light. The central light-based strand of our *cross*-shaped DNA appears to be *strengthened*, becoming more *visible* when one is spiritually “**born again**” in the LORD Jesus Christ. It is one of five *primary* ways our blood may be cleansed from various corruptions, returning our DNA to a more perfected state, that of God. Our 2 visible strands of DNA are tied to physical traits passed onto us by our mortal fathers and mothers, whereas the 3rd central strand reveals our connection to God. After Adam and Eve sinned, they were expelled eastward from Eden. Their mortal bodies changed, inheriting the seeds of death. The light originally in their veins was then replaced with blood. Author Ian Clayton believes that their 3rd DNA strand simply became less apparent or diminished at that time (see Ian Clayton, *Realms of the Kingdom*).

They needed healing and were promised a potential return to God via repentance and the saving blood of a future Savior. They were taught to offer up an appropriate sacrifice of an innocent lamb to God, pointing to this Redeemer. Its *pure blood* was a symbol of the Atonement of **the Only Begotten Son of the Father** (see Moses 5:5-9). This Son descended here to remove darkness and false priesthood among the people – those using them for “gain”. He then healed the believing and the faithful. Finally He provided them light and truth in His example and inspired instruction. He came to make “all things new” again (Rev. 21:5) in His blood Atonement.

Scripture tells us that those who are “born of God” (receiving the baptism of fire and the Holy Ghost) receive more light and have no desire to sin. John stated, “We know that whosoever is born of God sinneth not; but he that is **begotten** of God keepeth himself, and that wicked one toucheth him not” (1 John 5:18). “**Begotten**” may also mean carrying the *record* of who we are in the DNA. Christ is the “**Only Begotten**” of the Father in the flesh, carrying His DNA as part of His royal bloodline. The Patriarchal Order of Israel's kings held at least a portion of this pure bloodline through David, who became an adopted “son of God” (see also Mosiah 5:7-15). Throughout their history, the Israelites were commanded not to mix their special blood (and DNA) with other peoples outside of the 12 blessed Tribes of Israel. Such unions corrupted the purer bloodline of the patriarchal fathers like Abraham who came to know God.

In 1 John 5:18 we learn that Satan has little sway over those who are “born of God.” They become “alive” in God, relying more on the things of the Spirit. The physical world is no longer their most important reality. They have chosen to *overcome* the natural man in them. Such have been quickened by the presence of God and His *light*.

Our blood (which holds the *life* of the body, along our character and intention), is sanctified as we are “born again” in Christ Jesus. It is also called “the baptism of fire and the Holy Ghost” (see the author's paper, *Clear Born Again Scriptures*). Jesus told Nicodemus that this transforming *event* is essential if one is to “see” and “enter” heaven (see John 3:3-5). Nicodemus, although a master teacher among his people, was ignorant of this simple, important truth. He was part of a corrupted belief system that Christ called “a generation of **vipers**” (Matt. 3:7, 12:34, 23:33). They, like so many others, often abused the people for “gain”. Addressing the controlling Pharisees, Jesus said:

“Ye are of **your father** the devil, and the lusts of **your father** ye will do. He was a *murderer* from the beginning, and abode not in the truth, because there is no truth in him. When he speaketh a *lie*, he speaketh of **his own**, for he is a *liar*, and **the father** of it” (John 8:44).

Overcoming the world, as Christ did, is a central, defining topic in John's book of Revelation. He lists 7 types of “overcoming” as goals for true believers in chapters 2 and 3 of the book of Revelation. Each “overcoming” has a specific blessing. Wise virgins willingly embrace God's higher law contained in the 2 greatest commandments (a higher summary of the 10 commandments) and the 12 Beatitudes of the Sermon on the Mount (see endnote 11). Seeking God and living His higher law results in having more *light*. One Aramaic translation of The LORD's Prayer in Matthew 6 focuses on receiving more *light* that we might bring God's kingdom here to earth. It states:

Divine Parent in Heaven, holy is your name,
Fill my whole being with **Light**, your kingdom come,
Your Will be done on earth as it is in heaven.

Fill my Heart with Love,
Forgive my mistakes as I forgive others,
Guide me in the right use of sexual [creation] energy,
And in my relationship with the forces of nature.
Amen (to seal and confirm).

We know that our bodies are made up of 23 chromosomes given us from father and mother. They represent their combined earthly *record* given us. Is the third “*light*” portion of our DNA our *heavenly record* or scroll, tied to our spirit, character, and soul? Might it represent the combined traits of the Elohim (both heavenly parents)? The DNA within our blood bears *record* of our parents and our life too. It is a *marker* for who we really are. As we turn to God and are born again in Him, we are *sealed* to our Creator and Redeemer, receiving His *mark* and *name* upon us. We become His sons and daughters (Mosiah 5:7). The makeup of our DNA may thus reveal whether we have “the *seal* of the living God” or “the *mark* of the beast”.

The most important covenants on earth are made and *sealed* with blood. Leviticus 17:11 states, “For the life of the flesh is in the blood: and I have given it to you upon the altar to make an atonement for your souls: for it is the blood that maketh an atonement for the soul.” Our LORD’s blood Atonement can re-unite us with the Father, in a stronger 3-part relationship that helps us overcome the world. Wise King Solomon stated, “a threefold cord is not quickly broken” (Eccles. 4:12). The number 3 throughout scripture is tied to *spiritual strength* and *divinity*. We see the number 3 in connection with many events in the life of Christ in the New Testament. We know that He is one of **3 unified witnesses in heaven** - the Father, Son, and Holy Ghost. They are a reflection of **3 additional unified witnesses on earth** - in the elements of water, blood, and the Spirit, as addressed by John below.

“For there are **three** that bear record in heaven, the Father, the Word, and the Holy Ghost: and these *three are one*. And there are **three** that bear witness in earth, the Spirit, and the water, and the blood: and these *three agree in one*” (1 John 5:7-8, see also Moses 6:59-60).

The 3 witnesses in heaven *and* on earth may be mirrored in the 3 strands of DNA given Adam and Eve, our first parents. As we are born again in Jesus, the 3rd strand receives more light. We then become a son or daughter of God through the pure blood of Christ.

A New Creation in Purged Blood

The Prophet Joseph Smith taught how being **born again** effects us spiritually *and* physically. He stated that the effect is more pronounced upon a Gentile than one who is of the house or blood of Israel. He stated:

“The Holy Ghost has no other effect than *pure intelligence* (see JSH 1:59-60). It is more powerful in expanding the mind, enlightening the understanding, and storing the intellect with present knowledge, of a man who is of the literal seed of Abraham, than one that is a Gentile, though it may not have half as much *visible* effect upon the body; for as the Holy Ghost falls upon one of the literal seed of Abraham, it is calm and serene; and his whole soul and body are only exercised by the *pure spirit of intelligence*; while the effect of the Holy Ghost upon a Gentile, is to **purge out the old blood**, and make him actually of the seed of Abraham. That man that has none of the blood of Abraham (naturally) must have a **new creation** by the Holy Ghost. In such a case, there may be more of a powerful effect upon the body, and visible to the eye, than upon an Israelite, while the Israelite at first might be far before the Gentile in *pure intelligence*” (see TPJS, pps. 149-50).¹⁰

Internalizing His Flesh & Blood

In Communion, the Eucharist, or the sacred Sacrament ordinance, we symbolically partake of our LORD’s flesh and blood. They become part of us as we ingest His ways. In reality, the Atonement of Christ Jesus has great healing power in our physical bodies too. In His blood, the seeds of sin, death, and hell introduced in Eden are reversed. The *bitterness* of the effects of the fermented grape in Eden are reversed in the *sweet* new wine of our LORD’s Sacrament. There is *life* in His pure blood. Jesus said that He was “the resurrection and the *life*” as well as the “bread

of *life*” that came down from heaven (John 6:51). He is our source of *living* waters. We are encouraged to *frequently* consume His flesh and blood, that we might be made new in Him. Ian Clayton contends that consuming the emblems of our Master's sacrifice more often, and with proper intent, righteous living, and repentance, speeds the process of returning our DNA to God's divine, 3-strand DNA. The LORD Jesus said, “I am the *living* bread which came down from heaven: if any man eat of this bread, **he shall live for ever**: and the bread that I will give is my flesh, which I will give for the *life* of the world” (John 6:51).

These verses are not just about *living* again after we are resurrected, but *living forever* – now in mortality via translation. God desires that we increase in light, calling our central near-invisible strand of DNA into its fullness of glory. We have little life in us until we are “born again”, receiving the baptism of fire and the Holy Ghost. This is further strengthened as we righteously consume the emblems of the LORD's body and blood. Jesus stated, “Whoso eateth my flesh, and drinketh my blood, **hath eternal life**; and I will raise him up at the last day” (John 6:54). We can then **abide** in the Master (John 6:56), allowing Him to **live** in us. The LORD added, “This is that bread which came down from heaven: not as your fathers did eat manna, and are dead: **he that eateth of this bread shall live for ever**” (John 6:58). We have 3 witnesses of receiving “*life*” in John chapter 6. There the LORD Jesus tells us that if we eat His body and drink His blood **we will live forever**.

The Father placed His DNA in Mary (many believe She is Heavenly Mother, who came to earth as Eve and again as Mary). We too may obtain the power of transfiguration, translation, and resurrection, leading us to **life eternal** – if we turn fully to Father, Mother, and the Son. Those who reject Christ are incomplete with only 2/3rds of their DNA active. Turning to science and the world will result in further, negative modifications to our DNA. Such walk in darkness at midday (1 John 1:6; John 11:10). Those who repent and turn to God are grafted into the “tree of *life*”. They then may become fruitful branches of it, as they “abide” in Him as “the true vine”. We read in Revelation 2:7, “To him that overcometh will I give to eat of the tree of *life*, which is in the midst of the paradise of God.” John addresses 7 “Blessed” states tied to 7 “overcomings” of the world, all addressed in Revelation chapters 2 and 3.¹¹ Just prior to the shedding His pure blood in Gethsemane, the scourging, and the cross, the LORD taught His most trusted disciples the power inherent in the Sacrament Ordinance in the Last Supper. He stated:

“Take, eat: this is my body, which is broken for you: this do in remembrance of me.’ After the same manner also he took the cup, when he had supped, saying, ‘this cup is the new testament [covenant] **in my blood**: this do ye, as oft as ye drink it, in remembrance of me” (1 Cor. 11:24-25).

It is significant that the word “*remembrance*” comes from the Greek word for “**record**.” The divine *record* of God may be found more so in our blood, as it is cleansed from all corruption via the flesh and blood of Jesus. The greater light in the 3rd DNA strand can shine brilliantly in those who choose to become “alive” in Christ. Such are promised eternal *life*.

Summary

There is always hope in Christ Jesus. He is “the way, the truth, and the life” (John 14:6). There are a number of ways to combat the many modern corruptions of our bodies, blood, and DNA in this world. In them we may be healed, reversing the seeds of death brought on by the Fall in Eden *and* the many pollutions here. Some of the ways include:

1. *The Atonement of Christ* In it we are cleansed by the pure blood of the Savior, especially in the *born again* event – the baptism of fire and the Holy Ghost. It occurs as we turn fully to Jesus as our Redeemer.
2. *The Sacrament* As we ingest the *sacred emblems* of our LORD's flesh and blood with prayer, pure intent, and repentance, our bodies are renewed and made whole.
3. *Eating & Drinking Living Things* Healing can occur as we eat and drink healthy *living* things without the “seeds of death” in them. Pray that your food becomes the bread of *life* and your drinks *living* waters.
4. *Removing Darkness from your Life* Cast out demons, devils, unclean spirits and all darkness from your body and environment (Mark 16:17). Remove also false beliefs and trapped emotions, creating good energy flow. Eliminate the afflictions brought on by consuming modern media, entertainment, music and news wherever possible. Lift your soul by singing, praising, and thanking God.
5. *Associating with those of Greater Light* Physical creation on this earth involves the exchange of creation fluids. Mixing the seed of life with those of lesser light was forbidden among God's firstborn – the children of

Israel – the chosen people blessed by God’s covenant with father Abraham. When the covenant people “went a whoring after other gods”, they mixed their seed with people from surrounding cultures, polluting it. Some believe reversing this corruption is possible by also associating with those of greater light.¹²

Jesus is our amazing Healer. He is also our Creator, Redeemer, Judge and King. His blood and great wisdom have power to cleanse us and renew us. In Him there is hope, life *and* salvation. I pray you will seek His healing prior to His return. Come LORD Jesus, come!

End Notes - pages 29-34

¹ **The Aramaic & Palestinian Targums** (or “translations”) originated in the Hebrew language and were translated into Aramaic by Jewish priests in about 500 BCE. This was after the Jews returned to their homeland, following 70 years in Babylonian captivity. According to author Zen Garcia, the Aramaic and Palestinian Targum represents the oldest known translation of the Hebrew scriptures into another language - Aramaic. In Babylon, the average Jewish person began to speak the local Aramaic language rather than Hebrew. Upon return to the Holy Land, the priests (who spoke and wrote both Hebrew and Aramaic) translated the Hebrew Torah into Aramaic for the returning lay people, they who no longer spoke Hebrew. Later in 1862, J.W. Etheridge translated these Aramaic texts into English. *The Aramaic and Palestinian Targum*, edited by Zen Garcia, comes to us from this Aramaic to English translation by Etheridge. It is available from www.sacredwordpublishing.com and features a much less edited translation of the first five books of Moses, found in the Old Testament. I obtained this translation for the following reasons:

#1. The Aramaic translation returns Jesus Christ to the first five books of Moses in the creation account, the Passover story, and other important events in the early Old Testament books. There are some 251 references to Him there with 15 different name-titles, the most common being “the **Word** of the Lord” (see John 1:1).

#2. This translation also reveals the existence of the serpent’s bloodline upon this earth through Eve and Cain, along with how the fermented fruit of the vine (from the grape as the “forbidden fruit”) was used by the serpent to take advantage of Eve, introducing an opposing bloodline to that of God on earth. The Aramaic version of early Genesis and Numbers 6 (the Nazarite Vow) makes this event clear (see scriptures tied to #’s 1 & 10 in Part II of this paper).

#3. There are many other unique insights available in this early translation, the oldest know translation of the Hebrew scriptures into Aramaic first (500 BC) and then into English (1862).

The author is grateful for Mr. Garcia’s efforts in bringing forth this translation and his other works available on his website.

² **The JST Bible** There have been some 450 English translations of the Bible. One of these is the 1867 JST Bible, often called the Joseph Smith inspired re-translation of the 1611 King James Bible. It has been ignored by far too many people, primarily because it was received by revelation to the Prophet Joseph Smith, first leader of what later came to be known as The Church of Jesus Christ of Latter-day Saints (Mormon). In this unique “translation”, Joseph utilized an early 1611 King James Version of the Bible utilized by his parents. It featured 11 additional Apocryphal books in it, now removed from most modern KJV Bibles. Joseph Smith went through this Bible verse by verse, receiving specific changes via revelation, not by traditional language-to-language translation. He gave the 500-page manuscript of this “new translation” (which was never fully completed) to his wife Emma for safekeeping, as he feared that Brigham Young (second leader of this movement) would corrupt it, making changes to various verses to support polygamy and his “new order of things”. Emma thus held on to the manuscript as half of the Latter-day Saints left for the western wilderness after the murders of Joseph Smith and his two brothers Hyrum and Samuel Smith. About half the Saints followed Brigham Young west, beyond the borders of the United States at that time. There he could practice his version of Joseph’s early teachings, with his new focus upon polygamy. Emma and Joseph’s firstborn son - Joseph Smith III, published the JST Bible in 1867, 24 years after his father Joseph was murdered.

The changes in the JST Bible are often substantial, especially those in the first book of Genesis, where Christ is put back into the Creation account, much like the Aramaic Targum, we Christ remains in the Creation account. In just the first 8 chapters of JST Genesis (also called “The Book of Moses” among Mormons), we find 18 different names for Jesus Christ. Joseph Smith received significant instruction via revelation in what happened to Moses during his confrontation with Satan. This is not found in the KJV Bible. In it we see direct ties to “secret combinations” that involve oaths Satan makes with evil men on the earth, like Cain. They in turn make these oaths with one another here, that all might support one another in getting “gain” at expense of their brothers. This secrecy tied to getting “gain” is a primary message of the Book of Mormon, another book of scripture Joseph Smith brought forth earlier in 1830. It too is full of stories and prophecies relevant to our day tied to secrecy and corruption in governments *and* churches. They have occurred.

The doctrines of the gospel Joseph restored have now been corrupted in the modern day Mormon church (the term “Mormon” comes from one of the prophets in the Book of Mormon), and thus many outside of Mormonism will not consider reading either the JST Bible nor the Book of Mormon. This is a mistake, as both books are very much Christ-centered, full of truths that God can confirm with prayer, if one approaches them *and* God with an open mind and without personally held idols in the heart (see Ezek. 14). The same is true of the Aramaic Targum, Apocryphal books, or any extra-Biblical text. We can turn

to God in prayer as we read to obtain the truth of all things, as all books and papers have the errors of men in them, as well as useful truths. If we ask God “in the Spirit” to discern between light and darkness, we can receive truth and very directly. This is stated well in another source of scripture brought forth by Joseph Smith, the Doctrine and Covenants (a collection of revelations he received, now partly modified by men, much like the KJV Bible). See D&C 91:1-6 and 46:30.

³ **The DNA of Cain via his Demon-Father** The following Steve Quayle commentary is quoted from a conversation on DNA between a modern world class DNA researcher and an unidentified descendant of one of the “Illuminated Elite”. This descendant expresses concern over his ability to be “saved” within a bloodline that he said originated through Cain and a different father than Adam. See Zen Garcia, *Lucifer, Father of Cain*, Sacred Word Publishing.

“In his notes, my friend [the DNA researcher] penned some personal thoughts after having considered his observations and the source of his DNA materials. His benefactor [source of research finances]/test subject, and a family member from one of the Illuminated Elite who wanted his DNA tested for a third possible strand of DNA] believed that while most of the ‘**Sons of Adam**’ had **double strand DNA**, he had been told by his family [the Illuminated Elite] that he and his blood relatives were distinctly different - that he, like his father’s before him had triple strand DNA [like the alien Watchers]. He [my benefactor, the descendant of one of the Illuminated Elite] wanted my friend [the expert DNA researcher] to secretly prove once and for all if this was true [that he – the benefactor had **a third strand of DNA**] . . . or not. The subject [the descendant - benefactor] claimed that his extended family and their cousins, who are kings, queens, princes, and princesses, as well as leaders of industry and banking worldwide; believe they are children of an other-worldly race of ‘Humanoid Beings’. He had been taught by his tutor’s that once upon a time, his Ancestors had fallen to earth after some Cosmic Calamity in the time before . . . the Garden. He believed that while their ‘Ancestral Mother was Eve . . . their Ancestral father was **not Adam!**’ He was torn to know if a ‘Child of Cain’ was actually **genetically different** and whether **he could be saved?**”

He thought of the Vatican’s pronouncements that the Aliens [the Watchers] are our Cousins and the Vishnu teachings of a time when god’s flew in spaceships and destroyed whole cities in a single blast. The third strand of DNA supposedly part of the descendants of the Watchers (fallen “Sons of God” who came to earth, mating with mortal women – endnote #7) has some *marker* in it beyond the 3rd strand alone, an ungodly modification that may be closer to “the mark of the beast”, in connection with a different father.

⁴ **Jesus as Abel** If Jesus was Abel in a previous mortality, serving as the first sacrifice of a “*firstborn*” son in the Genesis story, does this potentially suggest that Adam and Eve may be our Father and Mother in heaven? Did they come here to begin the blessed bloodline of the Gods (or Elohim?) in this story, providing a mortal body for the Beloved Son Jesus in another mortality? Some say Mother came again as the wife of Joseph, Jesus’ stepfather in the meridian of time. These questions and so many others presented in this paper can only be answered in sincere prayer, if we are ready for the answers, and if we remove all “idols in our hearts” (things we believe to be true which are not, see the author’s paper “To Go No More Out”, about

⁵ Christ as the True Vine Jesus wanted all those who love Him and serve Him to enjoy His living energy—His spiritual reality, His Spirit and influence. We may continue to be nourished and sustained just as the roots and trunk of a **grape vine** produce the energy needed to nourish and sustain its **branches** - while they develop their **fruit**. The fruit can be sweet or bitter, like new wine or fermented wine. Though most cannot see the LORD Jesus, we can be closely connected to Him as the branches of a **vine** are connected to its stem, if we seek Him diligently and adhere to His words. Our desire to know and love Him, and the energy to serve Him, will keep flowing through us as long as we “abide” in Him as the vine. He said that no branch can live, let alone produce **fruit**, by themselves. Cut off from Him as the trunk, all branches die. Just as a **vine’s** branches rely on being connected to the trunk from which they receive their energy to bear **fruit**, we as Jesus’ disciples depend on being connected to Him for spiritual life and the ability to serve Him effectively. The **fruit** we produce is that of the Holy Spirit—love, joy, peace, patience, goodness, kindness, gentleness, faithfulness, and self-control (*Gal. 5:22–23*). Our source of life and spiritual fruit is not in ourselves, but in Christ Jesus, our Redeemer. We can live well as we abide in the True Vine Jesus via a faithful, loving relationship with Him. He truly is “the way, the truth, and the life” (*John 14:6*).

⁷ Nephilim Scriptures in the Bible The tall giants of scripture (some 24 references in the Bible) are called by various names. These include *Rephaim, Sons of God, Giborim, Mighty Men, Men of Renown, Watchers, Emim, Avvim, Amorites, Philistines, Sons of Anak* (Anakim), *Amalekites, Hittites, Jebusites, the Angels that Sinned, Sons of Perdition, Bastards, Reprobates*, and *the Children of Adultery*. They are believed to be *the Titans or Olympians* of Greek Mythology. They were found in the 5 ancient lands of Canaan, Gilead, Argob, Bashan, Gath, etc., and are among 5 named groups of giants or “strong peoples” in the walled cities within Canaan. They include the Biblical people known as the *Amalekites* [south], *Hittites, Jebusites*, and *Amorites* in the mountains, and the *Canaanites* along the seacoasts of Jordan. They are the makers of monumental “*cyclopean*” structures around the world, featuring masonry of large, tight-fitting stones, like those in Peru, Greece, and other settings. Skeletons of these giants are also found worldwide, many hidden away in the Smithsonian Museum. Some believe the Nephilim are tied to UFO’s and experimentation, and that New World Order leaders have contact with them today, using their higher technology for advantage.

8 The 4 Gospels and the 4 Creatures Around God’s Throne John the Beloved (also called “the Revelator”), and the potential literal son of Jesus and Mary in the Meridian of Time, is the writer of the 4th gospel in the New Testament, where the phrase “**the Word**” is presented us first with clear connections to Christ. John was called “beloved” by Jesus, just as Jesus was called “beloved” by His Father. John’s words provide an important witness for Christ, drawing specific attention to Him as **divine** (a God).

John was an Apostle called of the LORD and one who knew God well. He was chosen by Him to instruct us on the deeper things. We know that John was *with* Christ at his accusation before the High Priest in Jerusalem. John was with the LORD on the Mount of Transfiguration. He leaned upon His bosom at the Last Supper. He was near Him in Gethsemane. John was present at the crucifixion cross to witness His death. And he was first the Apostle to see that the LORD was no longer present in the tomb. John was given the unique mission to address Christ as a *divine* being in his first-hand witness in the 4th gospel. Note that this is one of 4 roles in Christ’s mission addressed below by each of the 4 gospel writers. These 4 unique roles provide additional reasons to love and honor Him with our whole *heart* (Lion), our *might* or *strength* (Ox), our *mind* (man), and our *soul* (eagle). These four roles are represented in the four creatures surrounding God’s throne in Revelation chapter 4, verse 7 and Ezekiel chapter 1, verse 10. Reading the 4 gospels, keeping each symbol in mind as we do so, gives us great insight into what each gospel writer is trying to convey to us.

Four Sides of Christ’s Mission

Matthew, for example, is showing us how Christ is the **Lion King**, the rightful heir of the throne over all Israel because of His blood (through the Father) and His righteousness. He is the promised Messiah and King, coming to save His people, the one prophesied throughout the Old Testament. Matthew’s gospel is focused on this King, His bloodline genealogy, and His kingdom. It is the bridge book between the Old Testament prophecies of Him, and the New Testament record of His fruits as this King and Redeemer. He is “the True Vine”, a source of nourishment and strength for His people.

John shows us that Yeshua was *with the Father from the very beginning*, and that He is also a **God**. It is in John chapters 7-10 that we read about Christ going to Jerusalem at **Tabernacles** to finally announce that He is both **God and the Son of God** (John 7:1-2). It was *there* and *then* that He announced to all that in Him was “*living water*” (the source of pure *revelation*, John 7:38). He latter added that He was also “the **Light** of the world” (the source of knowledge and power, John 8:12). These and other announcements, all tied to His **divinity** were made at **Tabernacles** in Israel’s capital city. He did so in connection with the symbols of *water* and *light*, both playing a central role at this particular feast.

It was also John who revealed another important announcement by Christ there, that He *was* and *is* “the great **I Am**” - the all-powerful one who met with Moses atop fiery Sinai, giving him the law for all Israel (John 8:58). Our LORD’s various statements of His *divinity* during **Tabernacles**, and His close connection to the Father, created such a stir that repeated attempts

were made to take His life, and by unbelievers who claimed to be Abraham's children. Christ labeled these deceivers as being the seed of another father, the devil - the father of lies and lust (see John 8:33-59). These and other statements led to our LORD's crucifixion 6 months latter at Passover.

Focused upon the law and other things, primarily for their own gain, the Jewish leaders were blind and unreceptive to the reality of who Jesus of Nazareth really was. John is the only New Testament writer to reveal another important event. It was when Roman soldiers and Jewish leaders came to arrest Jesus in Gethsemane (John 18). Here again John reveals the *divine* role of Jesus as the God of the Old Testament. John tells us that when Christ willingly identified that He was the one these men came to arrest, that He again stated that He was "**I AM**". John reveals that His accusers were then forced to the ground in His holy presence (see John 18:5-6). He came here to be the "**Lamb of God**" and thus allowed His captors to bind Him and take Him away to be tortured and crucified. John tells us what the LORD said about offering up His own life willingly – to those who had come to take it away. "**No one takes it from Me**, but I lay it down of Myself. I have **power** to lay it down, and I have **power** to take it again. This command I have received from My Father" (John 10:18).

¹⁰ **More of Joseph Smith's Words about being Born Again** Joseph Smith had profound words tied to the fiery baptism. He stated, "The baptism of water, without the baptism of fire and the Holy Ghost attending it, is of no use . . . They are necessarily and inseparably connected. An individual must be born of water *and* the spirit in order to get into the kingdom of God... You might as well baptize a bag of sand as a man, if not done in view of the remission of sins *and* getting of the Holy Ghost. Baptism by water is but half a baptism, and is good for nothing without the other half—that is, the baptism of [fire and] the Holy Ghost" (HC 6:316). Speaking of these two baptisms while addressing John the Baptist in JST Matthew 3:38, Joseph clarified, stating, "I baptize you with water, upon your repentance, but when Jesus Christ – of whom I bear record – comes, who has the power and keys, He will administer the baptism of fire and the Holy Ghost".

Addressing his own baptism, when the Holy Ghost came over Joseph and Oliver Cowdery in 1829, the Prophet Joseph stated, "Immediately on our coming up out of the water after we had been baptized, we experienced great and glorious blessings from our Heavenly Father. No sooner had I baptized Oliver Cowdery, than the Holy Ghost fell upon him, and he stood up and prophesied many things which should shortly come to pass. And again, I also had the spirit of prophecy, when, standing up, I prophesied . . . We were filled with the Holy Ghost, and rejoiced in the God of our salvation. Our minds being now enlightened, we began to have the scriptures laid open to our understanding, and the true meaning and intention of their more mysterious passages revealed unto us in a manner which we never could attain to previously, nor ever before had thought of" (JS History 1:73-74). ¹¹ **God's 7 Promises to Overcomers – Those Embracing the Higher Law** The higher law is embracing the 2 Great Commandments – to love God and love one another. It was rejected at Sinai and thus Moses brought down a 2nd set of lesser laws, the 10 Commandments. They detail how to live the 1st set of 2 greater commandments (the 1st 5 embrace loving God, the 2nd 5 embrace loving one another). Later in the New Testament, Christ taught a higher law in the **12** beatitudes of "the Sermon on the Mount", resulting in a "**Blessed**" state (see JST Matthew 5 & 3 Nephi 12). The KJV Matthew 5 account has only 9 Beatitudes, Luke 6 has only 4 of them (see *The Two Great Commandments of 12*, by the author).

John the Revelator also addresses the "**Blessed**" state in His book of Revelation, providing 7 Blessed states. They come when one "**overcomes**" the world (last-days Babylon). John lists 7 ways to overcome ourselves and this world in 2 important ways; We must, (1) "keep the commandments of God" and (2) "have the testimony of Jesus" (Rev. 12:17). These individuals will be part of God's *kingdom* of peace, justice, and love on the earth. John's 7 types of overcoming lead to becoming "**Blessed**" or being in or of "*the state of the gods*".

1. **Blessed** is he that readeth, and they that hear the words of this prophecy, and keep those things which are written therein: for the time is at hand (Rev. 1:3 KJV).
2. **Blessed** are the dead which die in the Lord from henceforth: Yea, saith the Spirit, that they may rest from their labors; and their works do follow them (Rev. 14:13).
3. **Blessed** is he that watcheth, and keepeth his garments, lest he walk naked, and they see his shame (Rev. 16:15)
4. **Blessed** are they which are called unto the marriage supper of the Lamb (Rev. 19:9).
5. **Blessed** and holy is he that hath part in the first resurrection: on such the second death hath no power, but they shall be priests of God and of Christ, and shall reign with him a thousand years (Rev. 20:6).
6. **Blessed** is he that keepeth the sayings of the prophecy of this book (Rev. 22:7).
7. **Blessed** are those who wash their robes [in the blood of Christ by believing and trusting in Him—the righteous who do His commandments], so that they may have the right to the tree of life, and may enter by the gates into the city (Rev. 22:14 AMP).

The **7 great blessings** (below) may be tied to the **7 over-comings** of this world (above). They are:

1. The LORD will give them the fruit of the Tree of Life (Rev. 2:7).
2. They shall not be hurt by the second death (spiritual death, Rev. 2:11).
3. If they endure to the end (after overcoming) they will have power over the nations - with a rod of iron, and they will receive "the morning star" (Rev. 2:26-28).
4. They shall be clothed in white raiment and their name will not be blotted out of the book of life. Their name will be confessed by Christ before the Father and His angels (Rev. 3:5).
5. The LORD will make them a pillar in the temple of God. They shall "go no more out." God's name will be written on them, along with the name of city of God (New Jerusalem). And the LORD will write upon them my new name (Rev. 3:12).
6. They will "sit with with me in my throne" (Rev. 3:21).
7. God says, they will be like me, as "I overcame, and am set down with my Father in His throne" (Rev. 3:21).

¹² **Creation** activity and energy is divine and is very powerful. Satan has corrupted sacred sexuality, making it something less than it really is.
